---

Demolish a ca. 1899 house.

---

**ARCHITECTURE**

---

One-story, rectangular-plan, hipped-roof, frame house with a full-width inset porch on battered wood posts and brick piers; 1:1 fenestration.

---

**RESEARCH**

---

The house appears on the 1900 Sanborn map, but there is no conclusive evidence from city directories as to who lived here at that time – the first time the address appears is in the 1903-04 directory. R. Pickens Matthews, a cotton buyer, lived here from around 1902 to around 1910. Andrew J. Speegle, a contractor, lived here from around 1912 to around 1917, and again from around 1921 to 1925. In between, the house was rented, first to a railroad clerk, then to a barber. From around 1928 to 1930, the house was rented by Elbert and Eldora McEachern; he was a driver for the Hyde Park Floral Company when he lived here – he later went on to be a salesman for a flower shop, and later a caretaker of the city cemetery. He died in a boating tragedy with his brother, in Gonzales in 1971.

Another carpenter/contractor, Eugene Morris, lived here with his wife, Emily, in the early 1930s. Drug store salesman Lester Arbuckle, and his wife, Annie, lived here in the mid-1930s. Lester Arbuckle was shot and killed in the liquor store where he worked (at 70 years old) in a 1972 robbery. Louie and Lillian Raven owned the house from the mid-1930s until around 1940. With his brother, Jesse, Louie Raven operated Raven's Garage, a long-standing auto repair garage on Red River Street, where a live-music venue and nightclub called "Raven's Garage" opened in the 1980s, and which later became Emo's. From the 1940s through the 1980s, the house has been associated with the Soto family. Rev. Felix E. Soto, Sr. devoted himself to the Methodist Church of the Rio Grande District throughout his career in Austin. His son, Felix E. Soto, who lived here with his wife, Amparo, was Austin's first Mexican-American city bus driver; he retired from the Austin Transit Company after many years of service.

**STAFF RECOMMENDATION**

---

Encourage relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

##### **R. Pickens Matthews (ca. 1902 – ca. 1910)**

The 1900 U.S. Census shows Rufus P. and Frances [?] Matthews living in rural Travis County. He was 28; she was 27; they had no children. He is listed as an assistant book-keeper. Both had been born in Texas.

R. Pickens and Eddie Matthews are listed in the 1910 U.S. Census report living at 1503 E. 1<sup>st</sup> Street. Both were then 36 years old; both had been born in Texas. He is listed as a cotton classer; she had no occupation listed. They had no children listed.

The 1920 U.S. Census report shows Rufus P. and F. Eddie Matthews living at 611 Baylor Street, a house they owned. He was a cotton classer; she had no occupation. They had no children listed.

Funeral services for R. Pickens Matthews of Austin, who died Monday morning at 2:30 a. m. at his

home, 611 Baylor street, will be held Tuesday morning at 10:30 a. m. from the First Methodist church, the Rev. W. F. Bryan officiating.

Mr. Matthews for 23 years was a cotton buyer for the W. T. Caswell company and was chief cotton classer for that concern. He was a native of Travis county and a son of the first sheriff of Travis county. Death occurred after a lingering illness.

### Andrew J. and Mary Speegle (ca. 1912 – ca. 1917 and ca. 1921 – ca. 1925)

Andrew J. and Mary Speegle are listed in the 1910 U.S. Census report living at 94 Rainey Street with their daughter Salome and son Jackson. Andrew J. Speegle was then 57, had been born in Arkansas, and was a carpenter/contractor. Mary Speegle was then 53, had been born in Texas, and had no occupation listed. Their children, Salome, 17, and Jackson 12, had been born in Texas.

The 1920 U.S. Census shows Andrew and Mary Speegle living on E. 25<sup>th</sup> Street, but without a house number. He was then 67; she was then 63. He is listed as a house carpenter. They had no children living with them.

The 1930 U.S. Census shows Mary Speegle as a widow, living in the home of her daughter Salome, and her husband, Erle Henry, at 608 E. 25<sup>th</sup> Street. Mary Speegle was then a 73-year old widow with no occupation listed. Her son-in-law, Erle Henry, was then 39, and was an automotive service manager.

# CONTRACTOR, RETIRED, DIES

## A. J. Speegle Survived By Nine Children, Widow.

A. J. Speegle, 74, died suddenly at the home of his daughter, Mrs. Earle Henry, 608 East 25th street, at 1 o'clock Friday afternoon.

Mr. Speegle was a contractor in Austin for almost 50 years, having retired from business about a year ago. He and his wife lived at their new home on 44th street, but during the past two months he had been staying with Mrs. Henry as he had been ill. Thursday morning he went to the downtown section of Austin to talk with old friends. He returned home sick. He died Friday.

Mr. Speegle was born at Fort Smith, Ark., Jan. 24, 1852. He left with his parents and moved to Bastrop county when he was 12 years old. He married Miss Mary Henry of Bastrop county.

For the past 22 years Mr. Speegle has made his home in Austin, living for the past 50 years in and around the city.

They had two children, son Gale, 7, and daughter Lois, 2. They also lived with Bessie's brother, Leslie Burgess, who was 18 and worked as a bank book-keeper. Joe Rowley is listed as a barber with his own shop. They rented the house.

Elbert McEachern was then 26 years old, had been born in Texas, and was a salesman for a floral shop. Eldora McEachern was then 24, had been born in Texas, and had no occupation listed. They had an infant son, Bobby. With them lived Elbert's sister, Lucille, 19, who worked as a saleslady at a department store. By 1940, Elbert and Eldora McEachern were living at 2803 Cameron Road (in today's French Place), a house they owned. Elbert McEachern was a caretaker of the City Cemetery.

The 1930 U.S. Census shows Lester and Annie Arbuckle renting a house at 302 Willow Street with their young daughter, and Annie's sister, Ruth Peterson. Lester Arbuckle was then 28, had been born in Texas, and was a drug store salesman. Annie Arbuckle was then 22, had been born in Texas, and had no occupation listed. Ruth Peterson was a 26-year old bookbinder. According to the 1920 U.S. Census, Lester Arbuckle was the son of Ida Arbuckle, a widow who lived on Manor Road on a farm. He was listed as a business college student. The 1910 U.S. Census reveals that Lester's father's name was Joe, who farmed in eastern Travis County.

# Aged Clerk Shot Dead In Robbery

A 70-year-old clerk was shot to death Thursday afternoon during the armed robbery of an East Austin liquor store.

Dead is Lester C. Arbuckle of 3407 Robinson. Municipal Judge Ronald Earle ruled Arbuckle's death a homicide.

Police Lt. Colon Jordan said Arbuckle was shot about 4.30 p.m. Thursday during an apparent armed robbery of Yeates Beer and Liquor Store at 1815 E. 12th St.

"We received a call about the robbery from an unidentified person who said there had been a holdup and that Arbuckle had been shot," the lieutenant said.

Jordan said another clerk, Charles McAlister of Route 6 Austin, had taken the store's receipts to the bank about 20 to 25 minutes before the holdup occurred and was not in the store at the time of the robbery.

"While Arbuckle was alone in the store," Jordan said, "someone came into the place, emptied three cash registers and shot him (Arbuckle)."

When police arrived at the scene of the robbery, the lieutenant said, Arbuckle was lying behind a counter, about mid-way down the length of the store.

"He was alive when the first officer arrived," Jordan said. However, a Brackenridge Hospital spokesman said Arbuckle was dead on arrival.

He was shot once in the heart, Jordan said.

Police questioned several persons at the scene of the holdup, but late Thursday night Jordan said homicide detectives

had no suspects in connection with the robbery - shooting.

"I've known Mr. Arbuckle for many a year," said G. P. Longmire, manager of the nearby Tartan Store, 1813 E. 12th St. "He was one of the best guys I've known all my life."

Longmire, who said he had worked with Arbuckle in the past, described Arbuckle as "the kind of the guy who would do anything in the world for you."

"Practically all folks around here knew him," Longmire said. "I can't imagine who would want to shoot that poor old man for a few dollars."

Funeral for Arbuckle is pending at Cook-Walden Funeral Home.

He is survived by his wife, Mrs. Annie Arbuckle, Austin; son, Brady Arbuckle, Austin; daughter, Mrs. Margaret Fugler, Marshall; four brothers, Gene Arbuckle, Woodrow Arbuckle, Inar Arbuckle, all of Austin; and Ralph Arbuckle of Alice; a sister, Miss Bueh Arbuckle, Austin and 23 grandchildren.

**Louis and Lillian Raven (ca. 1934 – ca. 1940)**

The 1940 U.S. Census shows Louie and Lillian Raven as the owners of a house at 1008 E. 38<sup>th</sup> street in Austin. Louie Raven was then 39, had been born in Texas, and was an automobile mechanic with his own garage. Lillian Raven was then 32, had been born in Texas, and was a public school teacher. They had two children: Leissner, 3; and Sharon Gale, 1.

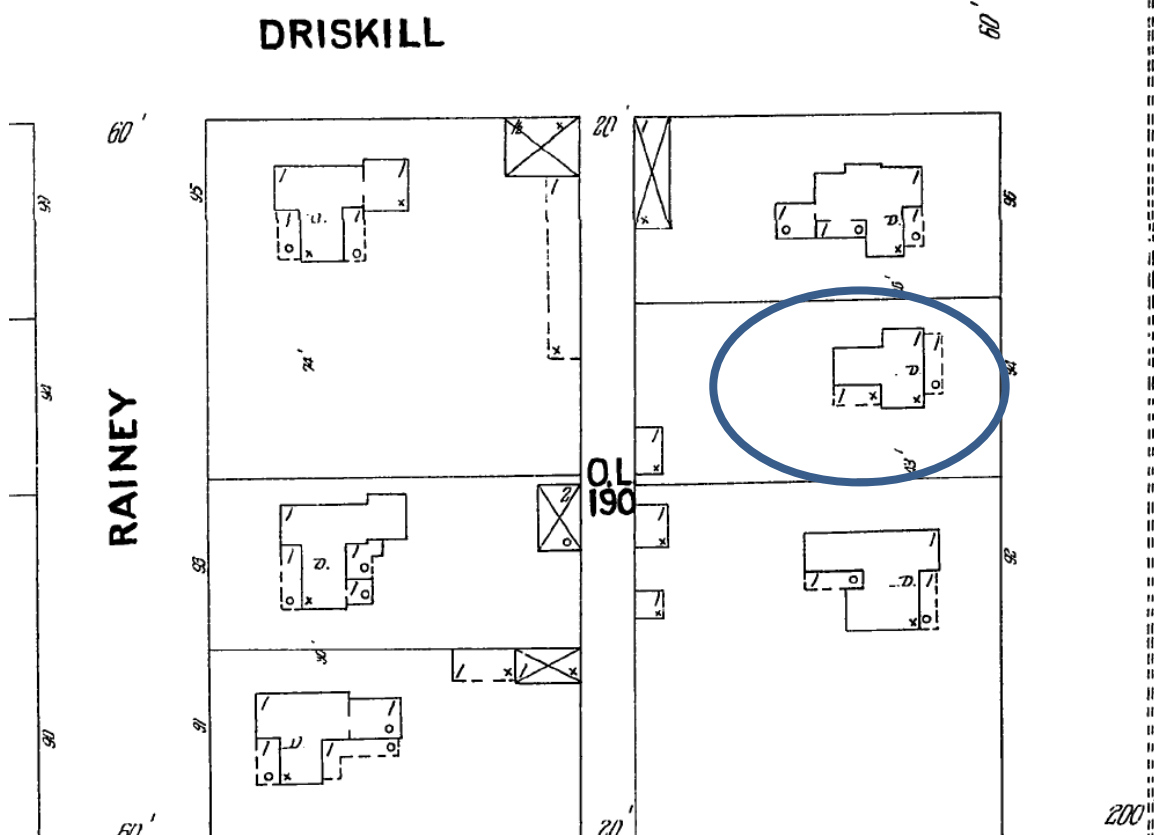

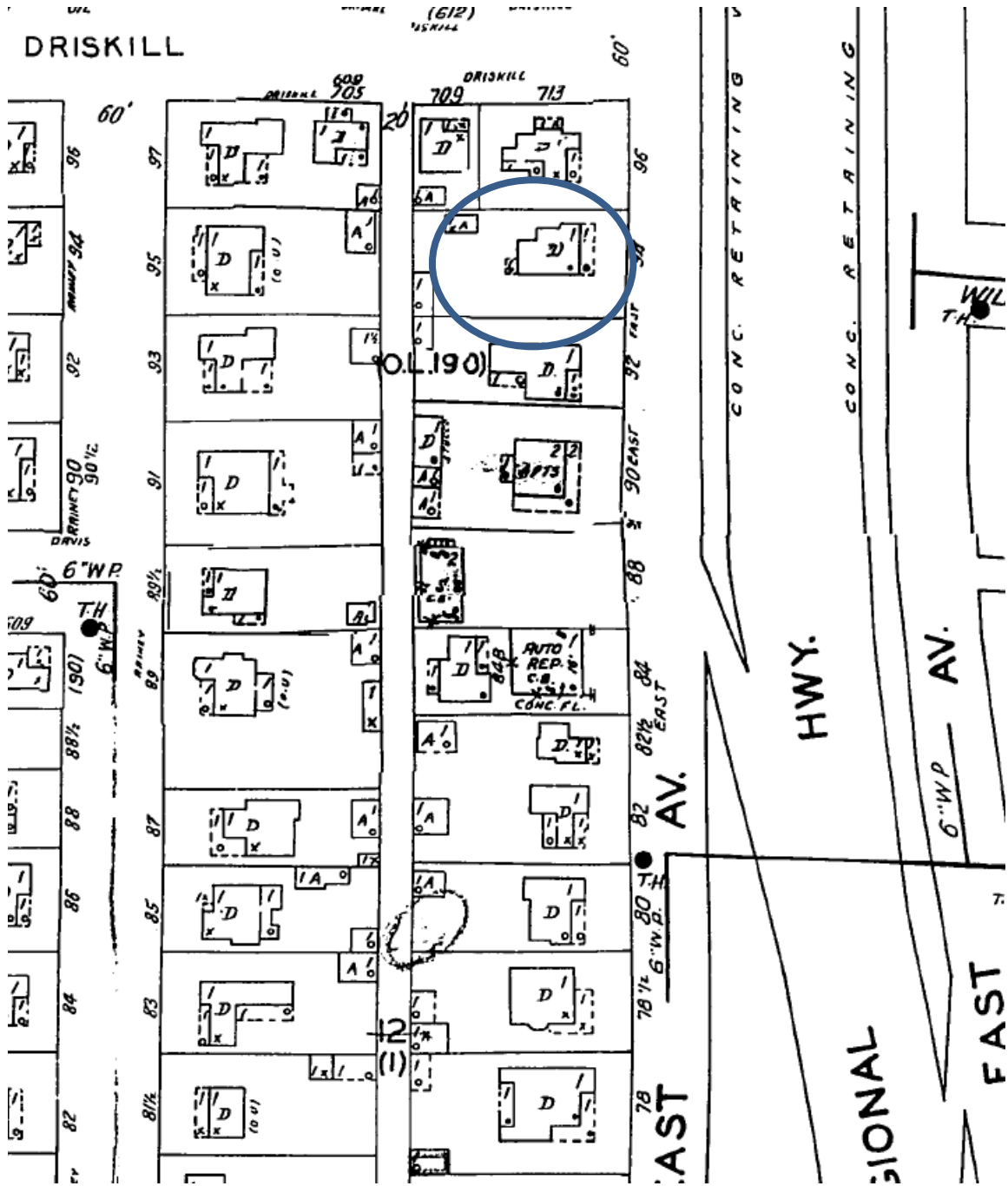

The house appears on the 1900 Sanborn map, but has a side porch on the south that had been enclosed by 1935, as shown on the map below.





The 1961 map shows the same configuration as the 1935 map above.
