Additional Backup Information

The Animal Services Office (ASO) was recently notified that the Texas Department of State Health Services (DSHS), Zoonosis Control Branch, was awarding the City \$15,295 through the Animal Friendly Spay/Neuter Grant Awards program. The funding is August 31, 2013 through August 31, 2014. The awards are made possible by the Animal Friendly License Plate Program; however, applications must be submitted to receive any portion of the earmarked proceeds.

The grant appropriation in the 2012-2013 Budget was \$15,000. The requested increase represents the difference between the grant appropriation of \$15,000 and the grant award amount of \$15,295.

Since August of 2000, the Animal Services Office, formerly the Animal Services Division of HHSD, has worked

diligently to decrease the number of euthanized adoptable dogs and cats by funding a free mobile spay/neuter clinic service for low-income families. The City contracts with Emancipet, Inc. on an annual basis and sterilizations are performed by a licensed veterinarian. Emancipet, a local non-profit organization, is the only mobile high volume spay/neuter service provider that offers professional veterinary services targeted to low-income pet owners in the Austin/Travis County area. The surgical cost per animal is well below the average market cost.

The General Fund will not be required to contribute to this grant. All department grant application requests are reviewed by the Budget Office prior to submission to ensure that the grant minimizes the financial impact to the City.
