Authorize award, negotiation, and execution of a 36-month supply contract with INDUSTRIAL ASPHALT, INC., for hot mix cold-laid asphaltic concrete (“hot mix”) for use by the Watershed Protection Department and the Parks and Recreation Department in an amount not to exceed \$372,600, with three 12-month extension options in an amount not to exceed \$124,200 per extension option, for a total contract amount not to exceed \$745,200.

Amount and Source of Funding

Funding in the amount of \$8,590 is available in the Fiscal Year 2012-2013 Operating budget of the Watershed Protection Department, and in the amount of \$1,760 is available in the Fiscal Year 2012-2013 Operating Budget of the Parks and Recreations Department. Funding for the remaining 35 months of the original contract period and extension options is contingent upon available funding in future budgets.

This contract supplies approximately 2070 tons of hot mix cold laid asphaltic concrete ("hot mix") to be used on an as needed basis by:

The Watershed Protection Department uses hot mix for stormdrain maintenance and construction activities as a temporary asphalt pavement for repairs, temporary sidewalk construction, gutter construction, and temporary driveway construction.

The Parks and Recreation Department utilizes hot mix-asphaltic-concrete materials for repair of roads, potholes parking lots, construction activity, pavement, and all other associated damages to Park land as required.
