Authorize award and execution of a 36-month supply contract with LAUREN CONCRETE, LP, for ready mix concrete in an amount not to exceed \$1,146,735, with three 12-month extension options in an amount not to exceed \$382,245 per extension option, for a total contract amount not to exceed \$2,293,470.

Amount and Source of Funding

Funding in the amount of \$21, 236 is available in the Fiscal Year 2012-2013 Operating Budget of the Watershed Protection Department. Funding for the remaining thirty-five months of the original contract period and extension options is contingent upon funding in future budgets.

This contract is for the supply of ready mix concrete to be used by the Watershed Protection Department and Public Works Department, Street & Bridge Division on an as needed basis.

Watershed Protection will use the concrete mix for storm-drain maintenance and construction activities, including storm-drain installations, inlet repairs and installations, concrete pavement repairs, concrete utility cut repairs, sidewalk construction, gutter construction, and driveway construction.

Street & Bridge will use the ready mix concrete for concrete pavement repairs, concrete utility cut repairs, sidewalk construction, American Disability Act (ADA) ramp construction requirements, curb and gutter construction, driveway construction and bus stop pad construction by City crews.
