

Council Audit and Finance Committee Meeting WEDNESDAY, August 7, 2013

MINUTES

THE *AUSTIN CITY COUNCIL AUDIT AND FINANCE COMMITTEE* CONVENED ON WEDNESDAY, AUGUST 7, 2013 AT 10:08 A.M. IN THE BOARDS & COMMISSIONS ROOM, FIRST FLOOR, ROOM 1101, CITY HALL, 301 W. 2nd STREET.

The meeting was called to order at 10:08 a.m. by Chair Sheryl Cole. In attendance were Council Member Bill Spelman, Council Member Laura Morrison, and Council Member Kathie Tovo.

Agenda Item #1: Citizen Communication

Agenda Item #2: Approval of June 26, 2013 minutes

Agenda Item #3: The Follow-Up Audit of the Historic Landmark Commission which

Patrick Johnson, Assistant City Auditor, presented results of the follow-up audit of the Historic Landmark Commission, which was led by Margot Wilson. Council Members had questions for the auditors and Janette Goodall, City Clerk. The follow-up audit was accepted on a motion by Council Member Spelman, seconded by Council Member Morrison, with a 4-0 vote.

Agenda Item #5: The Risk Assessment of Citizen Safety at City Facilities which identified

City departments for future audit work based on risks and controls in place related to citizens safety at City facilities (Office of the City Auditor)

Niki Raggi, Assistant City Auditor, presented the results of the Risk Assessment, which was led by Chris Shrout. Raggi and Ken Mory, City Auditor, answered Council Members' questions.
