Commission made several recommendations on the Community Connections site selection evaluation criteria, which included:

- -Whether the requesting organization will offer a new community service to the public as a result of the Google Fiber connection
- -Demographical information (ethnicity, gender, age and income levels) and geographic characteristics of the community members served by the organization
- -The partnerships of the organization
- -Does the organization currently have access to affordable, quality, high-speed broadband internet?
- -The availability and accessibility of the connection

The proposed selection criteria, timeline and process for identifying the sites to receive the Google Fiber Community Connection as well as additional comments by this Commission was approved on Commissioner Ramsey's motion; Commissioner Quintanilla second on a vote of 6-0
