1 AN ORDINANCE AMENDING THE FISCAL YEAR 2013-2014 GENERAL FUND  
2 OPERATING BUDGET (ORDINANCE NO. 20130909-001) REDUCING THE  
3 TRANSFER OUT TO THE ECONOMIC INCENTIVE RESERVE FUND; AND  
4 AMENDING THE FISCAL YEAR 2013-2014 EMERGENCY MEDICAL  
5 SERVICES DEPARTMENT OPERATING BUDGET (ORDINANCE NO.  
6 20130909-001) TO INCREASE APPROPRIATIONS; AMENDING THE FISCAL  
7 YEAR 2013-2014 ECONOMIC INCENTIVES RESERVE FUND OPERATING  
8 BUDGET (ORDINANCE NO. 20130909-001) REDUCING THE TRANSFER IN  
9 FROM THE GENERAL FUND AND DECREASING TOTAL REQUIREMENTS  
10 FOR COSTS ASSOCIATED WITH THE MEET AND CONFER AGREEMENT  
11 BETWEEN THE CITY AND THE AUSTIN/TRAVIS COUNTY EMERGENCY  
12 MEDICAL SERVICES EMPLOYEES ASSOCIATION.

14 BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

16 **PART 1.** The Council amends the Fiscal Year 2013-2014 General Fund Operating  
17 Budget (Ordinance No. 20130909-001) reducing the transfer out to the Economic  
18 Incentives Reserve Fund in the amount of \$2,160,895.

19 **PART 2.** The Council amends the Fiscal Year 2013-2014 Emergency Medical  
20 Services Department Operating Budget (Ordinance No. 20130909-001) to increase  
21 appropriations by \$2,160,895 for costs associated with the Meet and Confer Agreement  
22 between the City and the Austin/Travis County Emergency Medical Services Employees  
23 Association.

25 **PART 3.** The Council amends the Fiscal Year 2013-2014 Economic Incentives  
26 Reserve Fund Operating Budget (Ordinance No. 20130909-001) reducing the transfer in  
27 from the General Fund in the amount of \$2,160,895 and decreasing total requirements by  
28 the same amount for costs associated with the Meet and Confer Agreement between the  
29 City and the Austin/Travis County Emergency Medical Services Employees Association.
