AN ORDINANCE AMENDING THE FISCAL YEAR 2013-2014 GENERAL FUND OPERATING BUDGET (ORDINANCE NO. 20130909-001) REDUCING THE TRANSFER OUT TO THE ECONOMIC INCENTIVE RESERVE FUND; AND AMENDING THE FISCAL YEAR 2013-2014 EMERGENCY MEDICAL SERVICES DEPARTMENT OPERATING BUDGET (ORDINANCE NO. 20130909-001) TO INCREASE APPROPRIATIONS; AMENDING THE FISCAL YEAR 2013-2014 ECONOMIC INCENTIVES RESERVE FUND OPERATING BUDGET (ORDINANCE NO. 20130909-001) REDUCING THE TRANSFER IN FROM THE GENERAL FUND AND DECREASING TOTAL REQUIREMENTS FOR COSTS ASSOCIATED WITH THE MEET AND CONFER AGREEMENT BETWEEN THE CITY AND THE AUSTIN/TRAVIS COUNTY EMERGENCY MEDICAL SERVICES EMPLOYEES ASSOCIATION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

- **PART 1.** The Council amends the Fiscal Year 2013-2014 General Fund Operating Budget (Ordinance No. 20130909-001) reducing the transfer out to the Economic Incentives Reserve Fund in the amount of \$2,160,895.
- **PART 2.** The Council amends the Fiscal Year 2013-2014 Emergency Medical Services Department Operating Budget (Ordinance No. 20130909-001) to increase appropriations by \$2,160,895 for costs associated with the Meet and Confer Agreement between the City and the Austin/Travis County Emergency Medical Services Employees Association.
- **PART 3.** The Council amends the Fiscal Year 2013-2014 Economic Incentives Reserve Fund Operating Budget (Ordinance No. 20130909-001) reducing the transfer in from the General Fund in the amount of \$2,160,895 and decreasing total requirements by the same amount for costs associated with the Meet and Confer Agreement between the City and the Austin/Travis County Emergency Medical Services Employees Association.
- **PART 3.** This ordinance takes effect on ______ 2013.
