## Subject

Authorize execution of a construction contract with DENUCCI CONSTRUCTORS, LLC, for 3rd Street Reconstruction Phase 2 Project, from Congress Avenue to Brazos Street and San Jacinto Boulevard to Trinity Street, in the amount of \$2,365,343 plus a \$236,534.30 contingency, for a total contract amount not to exceed \$2,601,877.30.

## Amount and Source of Funding

Funding in the amount of \$2,517,920.24 is available in the Fiscal Year 2012-2013 Capital Budget of the Public Works Department. Funding in the amount of \$83,957.06 is available in the Fiscal Year 2012-2013 Capital Budget of the Austin Water Utility.

MBE / WBE: This contract will be awarded in compliance with City Code Chapter 2-9A (Minority-Owned and Women-Owned Business Enterprise Procurement Program) by meeting the goals with 6.68% MBE and 2.98% WBE subcontractor participation.

## Additional Backup Information

The City of Austin Public Works Department is improving eight blocks of 3<sup>rd</sup> Street right of way from Nueces Street to Trinity Street. The City entered into a Community Facilities and Cost Reimbursement Agreement with 3<sup>rd</sup> & Brazos, LP to design the proposed 3<sup>rd</sup> Street improvements for the three blocks between Congress Avenue and Trinity Street and to construct the 3<sup>rd</sup> Street improvements in the one block between Brazos Street and San Jacinto Boulevard. This one block of construction was recently completed; this construction contract will complete the proposed 3<sup>rd</sup> Street improvements in the blocks from Congress Avenue to Brazos Street and from San Jacinto Boulevard to Trinity Street. The five blocks of 3<sup>rd</sup> Street west of Congress Avenue are currently in design.

Work includes approximately 570 linear feet of concrete storm drain and associated appurtenances, 360 linear feet of ductile iron water line and associated appurtenances, full depth street reconstruction, widened sidewalks, street trees, typical Great Streets furnishings, and installation of the Lance Armstrong Bikeway with pre-cast concrete barrier curbs.

Area stakeholders have been kept informed throughout the project's design process and subsequent construction of the one block completed to date. The contract allows 295 calendar days for completion of this project.

This project is located within zip code 78701 and is managed by the Public Works Department.
