Proposal: Application for historic zoning.

Staff Recommendation: Recommend historic zoning as proposed.

MOTION: Approve the applicant's request to postpone the public hearing for this project to September 23, 2013 on Commissioner Myers' motion. Commissioner Wolfenden-Guidry second on a 4-0 vote.

Committee Recommendation: Lower the overall height of the new building.

Staff Recommendation: Approve per proposed design incorporating the Committee recommendations.

Committee Recommendation: Keep the house where it is and remove non-historic additions and modifications to preserve the current setbacks.

Staff Recommendation: Staff can support moving the house on the same site, but also recommends the Committee's recommendation to investigate

removal of non-historic additions before determining how far the house must be moved.

Committee Recommendation: Not reviewed.

Staff Recommendation: Approve the sign, but ensure that the proposed canopy will not obscure any architectural feature of the doorway, and **deny** the exposed bulbs on the bottom of the canopy.

Clifford Berry spoke in support. There were not speakers in opposition. The public hearing was closed on a motion by Commissioner Galindo. Commissioner Wolfenden-Guidry second the motion with a 4-0 vote.

Committee Recommendation: Set the railing back from the parapet, and set the deck use 15 feet back from the street façade of the Neches Street building.

Staff Recommendation: Approve the application as proposed with the request to set the railing and use as far back from the street façade as possible. The applicant has revised his plans for the deck in accordance with the recommendations of the Committee to move the railing back from the building parapet.
