Committee members supported their policy of generally not allowing construction of a structure within 10 feet of a property line.

Request: Approval of a dock extending thirty-eight (38) feet from shoreline

[Section 25-2-1176(B)(2)] A dock may not extend more than 30 feet from the shoreline unless the Parks and Recreation Board determines

that the dock will not create a hazard and approves the construction of

the dock.

Committee The committee voted 2-0 to offer the item for discussion with no Decision: recommendation. They directed staff to work with the applicant to

reduce the extension from 38 feet to a lower number.

Request: Approval of a dock extending sixty-five (65) feet from shoreline

[Section 25-2-1176(B)(2)] A dock may not extend more than 30 feet from the shoreline unless the Parks and Recreation Board determines that the dock will not create a hazard and approves the construction of

the dock.

Applicant: Bruce Aupperle
Owner: Ricardo Manllo Kuri
Location: 2908 Westlake Cove

Request: 1.) To construct a dock at 13 feet in width (23-28%), exceeding 20% of

the shoreline width [Section 25-2-1176(D)(2)] and; 2.) The Director of PARD shall determine, after receiving recommendation from the Parks and Recreation Board, the distance a dock may extend into a body of

water without constituting a hazard [Section 25-2-1176(B)(1)].

Committee The committee voted 2-0 to recommend approval and offer for Decision: discussion. Members instructed the applicant to receive more input from

the owners of neighboring docks.

F. ITEMS FROM BOARD MEMBERS Jane Rivera told the committee that the Lake Austin Task Force Draft Report had been released. One recommendation is to move all decisions related to boat dock site plans to another body. If this occurs the Navigation Committee would cease to operate and could become a committee focused on Lake concessions.
