Purpose



To provide information to the public about how General Obligation (GO) bonds and other Capital Improvement Program (CIP) funds are spent with the development of an online system at austintexas.gov (Council Resolution No. 20120927-085).

The resolution includes the following requirements:

- 1. Show how GO bonds and other funds are being spent on city infrastructure
- 2. Map of projects and programs
- 3. Key project information (e.g. description, status, funding, etc.)
- 4. Reports showing the geographic distribution of past and present infrastructure investments




