**1. CALL TO ORDER**

- a. Chair Rick Krivoniak called the meeting to order at 6:05 p.m.

**3. APPROVAL OF MINUTES**

- a. The minutes from the 8/13/13 meeting were approved on Commissioner Drennan's motion and Commissioner Hilliard's second on a 6-0 vote.

**4. BRIEFINGS**

- a. Greg Canally, Deputy CFO, City of Austin, Financial Services Department, provided a financial update on Mueller's overall project costs and current and anticipated future tax increment financing (TIF) debt obligations.
- b. John-Michael Cortez with Capital Metro provided updates on Project Connect, the transit planning and projects underway for the region, and the upcoming Central Corridor public meetings and process to select a locally preferred alternative for the first investment.
- c. Dee Desjardin provided an update on several planning issues related to Mueller, including a proposed school summit to be held this winter; Mueller resident participation at public meetings regarding single-member districts; Catellus continuing to work with Diana McIver and Associates on options for the affordable multi-family workforce housing since the project did not receive tax credit financing; and the Town Center Working Group being formed.

- a. Commissioners discussed opportunities for outreach with neighborhoods surrounding Mueller and community leaders regarding Mueller and other neighborhood issues. Commissioners discussed forming a Working Group around this topic.

  - The motion to draft and send a letter to Council to recommend reconsidering the sunset date for the Commission was approved with amendments on Commissioner Hilliard's motion, Commissioner Walker's second on a 6-0 vote.
