> I am not privy to the NA officers' discussions, nor do I wish to insert myself in the Southwood decision-making process. I simply address you as a concerned neighbor who has been part of the SACN Planning process from the beginning as well as a coleader of the GAVA '45 Initiative, etc., and wish to echo and add my concerns about this "Coalition" map and emphasize certain points.

>

> First, this map moves the southeast quadrant of the South Austin Combined Neighborhood Planning area into a different district-with Dove Springs, in fact. This contradicts the testimony we have been giving at the public hearings and other ICRC meetings for many weeks now.

>

> It also attaches most of the SACN area to a district that will be based and weighted in the major precincts in 78704, which contradicts the stated wishes of most (not all, I understand) residents of our community that we have more of a community affinity with other neighborhoods south of Ben White than those north (I write this fully understanding that only SANA has an official position supporting this point).

> I am further concerned that, in addition to either ignoring or being unaware of the expressed wishes of this community, the coalition neighborhoods, as best I can tell, included no neighborhoods south of Ben White, nor, as far as I can tell, were any invited to participate. I believe that is significant.

>

> At any rate, I wholeheartedly agree with Joan, Eliza, and others that our community's

progress and future accomplishments amy be slowed or somewhat sidetracked. Also, to the south in the ICRC 5 we have found allies with common interests and goals that we probably didn't know we had. I also agree with them that we need allies. I like Mario Cantu's offer of support and hope there is agreement to take him up on that offfer. I also believe we may find allies to the east and I would be happy to reach out to them.

> Finally, I communicated with Francis Reilly about the 9:00 a.m.SACN meeting this Saturday, and he notes that it will be over by 11:00. As the ICRC meeting at the Southeast Branch library will begin at 10:30 we should be able to make it to both (Craig Tounget estimates public testimony will continue until 1:00). I will encourage Woodhue folks to show up, and for those who can't, send an e-mail to the ICRC).

> I apologize to those of you who may be put off by the length and intrusion of this email. I merely hope to continue the discussion and hope to assist in any way I can to continuing our community building through the cohesiveness of our neighborhoods.
