

REGULAR MEETING THURSDAY, OCTOBER 17, 2013

Invocation: Lt. Col. Henry Gonzalez, Austin Area Commander, Salvation Army

The following represents the actions taken by the Austin City Council in the order they occurred during the meeting. While the minutes are not in sequential order, all agenda items were discussed. The City Council of Austin, Texas, convened in a regular meeting on Thursday, October 17, 2013 in the Council Chambers of City Hall, 301 West Second Street, Austin, Texas.

Mayor Leffingwell called the Council Meeting to order at 10:35 a.m.

CONSENT AGENDA

1. Approve the minutes of the Austin City Council work session meeting of October 1, 2013 and regular meeting of October 3, 2013.

The minutes from the Austin City Council work session meeting of October 1, 2013 and regular meeting of October 3, 2013 were approved on consent on Council member Spelman's motion, Mayor Pro Tem Cole's second on a 7-0 vote.

- 4. Approve an ordinance repealing Exhibits A, B, C, D and G of Ordinance No. 20130808-007B ordering the November 2013 special municipal election, and replacing them with new exhibits that adopt changes to election day and early voting polling places, and list election day judges; and declaring an emergency.

 Ordinance No. 20131017-004 was approved on consent on Council Member Spelman's motion, Mayor Pro Tem Cole's second on a 7-0 vote.
- 5. Authorize the negotiation and execution of a construction contract with MATOUS CONSTRUCTION, LTD. for the Davis Water Treatment Plant Chemical Feed System Improvements Bid Package 2: Lime Slaker/Lime Slurry Feed System Improvements in the amount of \$1,995,000 plus a \$199,500 contingency, for a total contract amount not to exceed \$2,194,500. (Notes: This contract will be awarded in compliance with City Code Chapter 2-9A (Minority Owned and Women Owned Business Enterprise Procurement Program) through the achievements of good faith efforts with 7.32% MBE and 0.20% WBE subcontractor participation.)

DISCUSSION ITEMS

31. Approve an ordinance ending the pilot program which allowed biking on trails on a 24-hour basis by repealing Ordinance No. 20130131-028 and Ordinance No. 20130228-033. (Notes: SPONSOR: Mayor Lee Leffingwell CO 1: Council Member Kathie Tovo)

This item was postponed to October 24, 2013 with direction and friendly amendment as follows on Council Member Riley's motion, Council Member Spelman's second on a 7-0 vote. Direction was given to the City Manager to work with the Austin Police Department and the Neighborhood Connectivity staff within Public Works to identify particular trails that may remain open for 24 hours in spite of the curfew.

There was a friendly amendment made by Mayor Leffingwell to amend the above direction to the City Manager by directing him to look into possible exceptions from the trail ban rather than working with the staff. The amendment was accepted by the maker of the motion and Council Member Spelman, who made the second.

 - (4) The water quality controls on the redevelopment site must provide a level of water quality treatment that is equal to or greater than that which was previously provided.
 - (5) For a commercial or multifamily redevelopment, the owner or operator must obtain a permit under Section 25-8-233 (Barton Springs Zone Operating Permit) for both sedimentation/filtration ponds and SOS ponds.
 - (6) For a site with more than 40 percent net site area impervious cover, the redevelopment must have:
 - (a) sedimentation/filtration ponds for the site; or
 - (b) SOS ponds for a portion of the site, and sedimentation/filtration ponds for the remainder of the redeveloped site.
 - (7) For a site with 40 percent or less net site area impervious cover, the redevelopment must have SOS ponds for the entire site.
 - (8) The property owner must mitigate the effects of the redevelopment, if required by and in accordance with Subsection (H).
 - (9) Redevelopment may not be located within the Erosion Hazard Zone, unless protective works are provided as prescribed in the Drainage Criteria Manual.
- (F) City Council approval of a redevelopment in accordance with Subsection (G) is required if the redevelopment:
 - (1) includes more than 25 dwelling units;
 - (2) is located outside the City's zoning jurisdiction;
 - (3) is proposed on property with an existing industrial or civic use;
 - (4) is inconsistent with a neighborhood plan; or
 - (5) will generate more than 2,000 vehicle trips a day above the estimated traffic level based on the most recent authorized use on the property."

The first paragraph of part 35, section 25-8-261 should read, "In all watersheds, development is prohibited in a critical water quality zone except as provided in this Division. Development allowed in the critical water quality zone under this Division shall be revegetated and restored within the limits of construction as prescribed by the Environmental Criteria Manual."

The first paragraph of part 114, section 30-5-261 should read, "In all watersheds, development is prohibited in a critical water quality zone except as provided in this Division. Development allowed in the critical water quality zone under this Division shall be revegetated and restored within the limits of construction as prescribed by the Environmental Criteria Manual."

Part 17, section 25-8-92(A) and (2) should read,

- "(A) In the water supply rural watersheds, water supply suburban watersheds, and Barton Springs zone, a critical water quality zone is established along each waterway classified under Section 25-8-91 (Waterway Classifications)."
- "(2) Notwithstanding the provisions of Subsections (A)(1)(a), (b), and (c), a critical water quality zone does not apply to a previously modified drainage feature serving a public roadway right of way that does not possess any natural and traditional character and cannot reasonably be restored to a natural condition, as prescribed in the Environmental Criteria Manual."

Part 100, section 30-5-92(A) and (2) should read,

- "(A) In the water supply rural watersheds, water supply suburban watersheds, and Barton Springs zone, a critical water quality zone is established along each waterway classified under Section 30-5-91 (Waterway Classifications)."
- "(2) Notwithstanding the provisions of Subsections (A)(1)(a), (b), and (c), a critical water quality zone does not apply to a previously modified drainage feature serving a public roadway right of way that does not possess any natural and traditional character and cannot reasonably be restored to a natural condition, as prescribed in the Environmental Criteria Manual."

There was a friendly amendment made by Council Member Morrison to amend the ordinance by amending the roadway deduction in section 25-8-65 rather than deleting it. The amendment was not accepted by the maker of the motion.

There was a motion made by Council Member Morrison and seconded by Council Member Martinez to amend the ordinance as follows. The motion failed on a vote of 4-3. Those voting aye were Council Members Martinez, Morrison and Tovo. Those voting nay were: Mayor Leffingwell, Mayor Pro Tem Cole and Council Members Riley and Spelman.

The amendment were to 1) amend Part 14 to amend city code section 25-8-65 and amend Part 15 to renumber the new section as 25-8-66 and 2) amend Part 97 to amend city code section 30-5-65 and amend Part 98 to renumber the new section as 30-5-6.

Part 14

- "(A) This section applies only in the Water Supply Rural, Water Supply Suburban and Barton Spring Zone watersheds.
- (B) Except as otherwise provided in this section, impervious cover calculations for development adjacent to a roadway shall account for the adjacent roadway.
- (C) For development with an internal roadway, impervious cover calculations include the internal roadway, except that pavement width in excess of 44 feet is excluded. This does not reduce the requirements for stormwater detention facilities or water quality controls for run-off from the roadways.
- (D) For development adjacent to a roadway built as a City Capital Improvements Program project after May 18, 1986, impervious cover calculations include one-half of the pavement width, up to a maximum of 44 feet, and the associated right-of-way.
- (E) Application of this section shall not result in a reduction of allowable impervious cover over 25 percent."

Part 15

Renumber section 25-8-65 to read, "section 25-8-66 Commercial Impervious Cover". Part 97, section 30-5-65

- "(A) This section applies only in the Water Supply Rural, Water Supply Suburban and Barton Spring Zone watersheds.
- (B) Except as otherwise provided in this section, impervious cover calculations for development adjacent to a roadway shall account for the adjacent roadway.
- (C) For development with an internal roadway, impervious cover calculations include the internal roadway, except that pavement width in excess of 44 feet is excluded. This does not reduce the requirement for stormwater detention facilities or water quality controls for run-off from the roadways.
- (D) For development adjacent to a roadway built as a City Capital Improvements Program project after May 18, 1986, impervious cover calculations include one-half of the pavement width, up to a maximum of 44 feet, and the associated right-of-way.
- (E) Application of this section shall not result in a reduction of allowable impervious cover over 25 percent.

Renumber part 98, section 30-5-65 to read, "section 30-5-66 Commercial Impervious Cover".
