**Additional Backup Information**

The purpose of this project is to repair concrete pressure pipes. These pressure pipes could experience failure because of broken steel reinforcing wires. The rehabilitation and repair of these pipes will reduce the risk of failure and extend the life of the pipe assets.

This project includes: internally bonded carbon fiber-reinforced composite repair system design; Prestressed Concrete Cylinder Pipe (PCCP) waterline removal and installation by open cut methods; implementation and maintenance of traffic control; excavation safety systems; installation and maintenance of temporary erosion and sedimentation controls; and associated pavement repairs.

The work is located at MoPac at West 35<sup>th</sup> Street, West 34<sup>th</sup> Street from Oakmont to Seton Medical Parkway, Kerbey Lane at West 32<sup>nd</sup> Street, and West Lynn Street at 11 ½ Street.

Due to the potential for unknown subsurface conditions and potential conflicts when working in the right of way, a 10% contingency has been included to allow for the expeditious processing of any change orders.

The contract allows 60 calendar days for substantial completion of this project.

This project is located within zip code 78703 and is managed by the Public Works Department.
