ANALYSIS / ADDITIONAL INFORMATION: Austin Water Utility seeks authorization to negotiate and execute a Community Facilities Agreement with Seaholm Power Development, LLC, (“Seaholm”) for reimbursement of the design and construction costs associated with the installation of approximately 140 feet of 8-inch reclaimed water main, 150 feet of 12-inch water main, and 120 feet of 8-inch and 4-inch water service mains to provide reclaimed, domestic water and internal fire protection services in an amount not to exceed \$191,000.

The proposed agreement, pursuant to Section 271.908 of the Texas Government Code, allowing a local government entity to contract with private entities for the design, development, finance, maintenance, operation, or construction of civil works projects, includes the installation of a reclaimed water main and water mains to serve the new Central Library and the Seaholm Power Plant Redevelopment. Austin Water Utility expects to reduce costs and avoid delays through use of the proposed agreement which allows Seaholm’s General Contractor to install the necessary improvements concurrent with other construction work at the Seaholm site.

The proposed 140 feet of 8-inch reclaimed water main to be constructed under the proposed agreement will eventually become part of a larger reclaimed water project that will serve the Seaholm Power Plant Redevelopment and the new Central Library. Seaholm would construct the proposed 8-inch reclaimed water main during the construction of West Avenue, a requirement of the Seaholm Power Plant Redevelopment. The City will reimburse Seaholm for an amount not to exceed \$35,000.

Portions of an existing 12-inch water main that traverses east/west across the southern side of the Seaholm site will be relocated (approximately 150 feet) to provide a “looped” water system that is required to provide fire protection to the new Central Library and provide additional redundancy for the Seaholm Power Plant Redevelopment. The City will reimburse Seaholm for an amount not to exceed \$100,000.

Seaholm would design and construct approximately 120 feet of 8-inch and 4-inch water service mains with the West Avenue improvements. The water service mains would provide domestic water and internal fire protection water to the new Central Library. The City will reimburse Seaholm for an amount not to exceed \$56,000.
