## **ORDINANCE NO.**

## AN ORDINANCE WAIVING OR REIMBURSING CERTAIN FEES AND COSTS, AND WAIVING CERTAIN REQUIREMENTS FOR THE 2014 AUSTIN FARMER'S MARKETS AND THE 2014 HOPE FARMER'S MARKET AT PLAZA SALTILLO, CITY CO-SPONSORED EVENTS, DURING THE 2014 CALENDAR YEAR.

## **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**

**PART 1.** The 2014 Austin Farmer's Markets, a City co-sponsored event with the Sustainable Food Center, Inc., will be held at Republic Square Park, at the intersection of Triangle Avenue and 46<sup>th</sup> Street (bordering Triangle Park), and at the East Farmer's Market (near the intersection of East 51<sup>st</sup> Street and Highway 183) on selected days during the 2014 calendar year.

**PART 2.** The 2014 HOPE Farmer's Market at Plaza Saltillo, a City co-sponsored event, will be held at Plaza Saltillo, 412 Comal Street, Austin, Texas, on selected days during the 2014 calendar year.

**PART 3.** Food vendors for the 2014 Austin Farmer's Markets and the 2014 HOPE Farmer's Market at Plaza Saltillo shall follow the guidelines and requirements of City Code Chapter 8-3 (*Restrictions on Food, Beverage, and Containers*) and Chapter 10-3 (*Food and Food Handlers*).

**PART 4.** Council waives the following fees and charges for the 2014 Austin Farmer's Markets and the HOPE Farmer's Market at Plaza Saltillo. Fees that have been paid shall be reimbursed to the Sustainable Food Center, Inc. or HOPE Farmer's Market at Plaza Saltillo as appropriate.
