AN ORDINANCE REZONING AND CHANGING THE ZONING MAP FOR THE PROPERTY LOCATED AT 1701 RED RIVER STREET FROM MULTI FAMILY RESIDENCE MODERATE HIGH DENSITY (MF-4) DISTRICT, GENERAL COMMERCIAL SERVICES (CS) DISTRICT AND GENERAL OFFICE (GO) DISTRICT TO PUBLIC (P) DISTRICT.

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:

PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from multi family residence moderate high density (MF-4) district, general commercial services (CS) district and general office (GO) district to public (P) district on the property described in Zoning Case No. C14-2013-0135, on file at the Planning and Development Review Department, as follows:
4.25 acre tract of land, more or less, being a portion of Red River Street the tract of land being more particularly described by metes and bounds in Exhibit "A" incorporated into this ordinance (the "Property"),
locally known as 1701 Red River Street in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit " B ".

PART 2. This ordinance takes effect on December 23, 2013.
