Authorize award and execution of a 36-month requirements supply contract with BOUND TREE MEDICAL, to provide EMS and AFD with medical bags in an amount not to exceed \$80,537, with three 12-month extension options in an amount not to exceed \$26,846 per extension option, for a total contract amount not to exceed \$161,076.

Amount and Source of Funding

Funding in the amount of \$17,897 is available in the Fiscal Year 2013-2014 Operating Budget of the Emergency Medical Services Department. Funding for the 24-months of the original contract period and extension options is contingent upon available funding in future budgets.

Additional Backup Information

This contract will provide EMS and Fire Department with medical bags that are custom designed for paramedics and first responders. The bags used to safely secure medical devices and supplies including compressed medical gas, various airway devices and multiple forms of pharmaceuticals and are made to hold approximately twenty five pounds with shoulder or hand carry capability. These bags are essential to store and carry emergency medical supplies to patient's side in any emergency response condition.
