PART 1. The zoning map established by Section 25-2-191 of the City Code is amended to change the base district from single family residence standard lot (SF-2) district to limited office-conditional overlay (LO-CO) combining discitton the property described in Zoning Case No. C14-2013-0143, on file at the Planning and Development Review Department, as follows:

Lots 4 and 5, Block A, Tanglewood Forest Section Four Phase-E Subdivision, a subdivision in the City of Austin, Travis County, Texas, according to the map or plat of record in Plat Book 85, Page 116D and 147A of the Plat Records of Travis County, Texas (the "Property"),

locally known as 3 03 and 3105 West Slaughter Lane in the City of Austin, Travis County, Texas, and generally identified in the map attached as Exhibit "A".

PART 2. Property within the boundaries of the conditional overlay combining district established by this ordinance is subject to the following conditions:

- A. Development of the Property shall not exceed one driveway to West Slaughter Lane.
- B. The following uses are conditional uses of the Property:

Day care services (limited)

Day care services (general)

Day care services (commercial)

C. The following uses are prohibited uses of the Property:

Club/lodge


