- The 3-year process to update Austin's Land Development Code.
- A community collaboration between Austin's residents, businesses and the City of Austin.
- To align our regulations with the Imagine Austin vision of a better future for all Austinites.





#### **Imagine Austin Comprehensive Plan**




- Adopted community vision

### What is the Land Development Code (LDC)?

Regulations for the use and development of land:

- WHAT can be built
- WHERE it can be built
- HOW MUCH can be built
- HOW it can be used
- WHEN it can be used

The Code should respond to the "DNA" of an area: the streets, blocks, parks and open spaces, that make each place unique.







The Code should respond to the look and size of buildings as they relate to the street and to one another.



### Outreach Efforts to Date

- Interviews with about 100 stakeholders
- 4 large public listening sessions
- Direct contact with over 150 community organizations
- Presented to over 40 community groups
- Recruiting ambassadors from traditionally underrepresented communities

#### Input about **Biggest Issues** to address:

- Streamline, simplify, and eliminate Code conflicts
- Mobility, affordability, density, and diversity of housing
- Protection of neighborhood character and parks and open space
