REGULAR MEETING MINUTES MONDAY, January 6, 2014

Meghan Wells informed the Panel that Mark Schatz's artwork is installed at 2nd St and Trinity, and reminded the Panel that Ryan Thompson's tenure on the Panel is almost up and another panel candidate is needed soon.
