PROPOSAL

Demolish a ca. 1936 duplex.

ARCHITECTURE

Two-story, rectangular-plan, hipped-roof, frame garage apartment-style duplex with single and paired 1:1 fenestration on the ground floor and paired 1:1 fenestration on the second floor; all windows have 3:1 wood-frame screens. Central entry has a front-gabled hood on knee braces.

RESEARCH


The house was built in 1936 by Ben and Lillie Mae Mewis. Ben Mewis was a salesman for Kelly Smith Cleaners; Lillie had no occupation listed in census reports or city directories. The 1940 U.S. Census shows that Ben and Lillie Mewis shared this house with their daughter, Lillie's mother, and Lillie's nephew and niece, along with their young daughter. Lillie Mewis passed away in 1941; Ben Mewis then married a woman named Marguerite. He opened his own business, No Delay Cleaners, at 1117 S. Congress Avenue in the early 1940s; he and Marguerite lived here until around 1945. The house was rented to John E. and Virginia Schneider in the late 1940s; he was in the U.S. Army. Howard D. Tomerlin, and his wife, Marie, are listed as the owners of the house in the early- to mid-1950s; he was in the Air Force. By the late 1950s, it appears that the house was already being used by two families: Air Force couples rented the house in 1959, when the house had two addresses, 1002 and 1002½ S. 3rd Street. A real estate man, Henry Antoine, is listed as the owner in the 1960s; the house has since been used as a rental, with tenants including a public school teacher, and an employee of the Texas Tennis Association.

STAFF COMMENTS

The house does not appear in any City survey.

STAFF RECOMMENDATION

Release the permit upon completion of a City of Austin documentation package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center. The house has neither the architectural nor the historical significance to warrant individual designation as a historic landmark.

Benjamin F. and Marguerite Mewis (ca. 1941 - ca. 1945)

Ben and Lillie Mae Mewis appear as the owners of this house in the 1940 U.S. Census report. The house was worth \$1,400. Both Ben and Lillie Mae were then 39, both had been born in Texas. Ben was a salesman for a cleaner and presser; Lillie Mae had no occupation listed. With them lived their daughter, Charlotte Maxine, 13, Lillie's mother, Mary E. Newton, a 63-year old Alabama widow, and a couple, Brian and F. Estelle Fraser, with their daughter Sharon. Brian and F. Estelle Fraser are listed as the nephew and niece-in-law of Ben Mewis. Brian Fraser was 23, had been born in Canada, and was a butcher in a retail grocery store. F. Estelle Fraser was 24, had been born in Oklahoma, and had no occupation listed. Their daughter Sharon, 1, had been born in Detroit, Michigan, where the Frasers had lived in 1935.

The 1930 U.S. Census shows Ben and Lillie Mewis as the owners of a house in Wichita County, Texas, which was worth \$800. Ben was an insurance agent. Lillie had no occupation listed. Their daughter, Maxine, was 3. Lillie's mother, Mary Newton, was a practical nurse; she lived with Ben and Lillie.
