

**ORDINANCE NO.**

**AN ORDINANCE WAIVING OR REIMBURSING CERTAIN FEES AND REQUIREMENTS, AND AUTHORIZING PAYMENT OF CERTAIN COSTS FOR THE CITY CO-SPONSORED 2014 ZILKER PARK KITE FESTIVAL WHICH IS TO BE HELD SUNDAY, MARCH 2, 2014.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF AUSTIN:**
