#### 2. APPROVAL OF MINUTES

#### 6. NEW BUSINESS

a. Conceptual Mid-Design Presentation on 8<sup>th</sup> St. Streetscape Art in Public Places Project
 – Barna Kantor and Stan Pipkin, Artists

Jean Graham introduced the artists and gave a short overview of the project, noting that the artists' concept is moving the AIPP program in a somewhat new direction and implementation will demand a very collaborative approach. Artist Barna Kantor and Stan Pipkin presented the concept for creating an interactive public art work – a "walkpod" - as an open source interactive digital platform in the streetscape. This was followed by a discussion of the scope of work and goals of the project. No action was taken.

b. Approval of Artist Selection Process for Colorado Streetscape Enhancement Project (Phase 2) Art in Public Places Project

Carrie Brown presented the project outline for a Direct Selection of the artists commissioned for Phase 1 of this Great Streets project. Panel member Frank made a motion to approve the Artist Selection Process. Panel member Daigle seconded the motion. Motion was unanimously approved on a 4-0-0 vote. Chair Thompson and Panel members Hammonds and Walker were absent

c. Approval of Final Design for Terminal East Infill Art in Public Places Project
-- Mikyoung Kim, Artist (via GoToMeeting)

Carrie Brown gave an update on the status of this project and via GoToMeeting, Mikyoung Kim and her project manager Bill Madden presented the Final Design. Panel member Little made a motion to approve the Final Design. Panel member Frank seconded the motion. Motion was unanimously approved on a 4-0-0 vote. Chair Thompson and Panel members Hammonds and Walker were absent.

d. Conceptual Mid-Design Presentation on Auditorium Shores Trailhead Art in Public Places Project
-- Andrew Bellatti Green and Adam Pyrek, Artists

Anna Bradley outlined the project parameters and introduced the artists. Andrew Bellatti and Adam Pyrek presented two alternate directions for the artwork at Auditorium Shores Trailhead and received feedback from AIPP Panel members on these designs. No action was taken.

Carrie Brown presented an update on the design for the barrier around the artwork for the CONRAC Art in Public Places project and the Northwest Greenway project at Mueller. Jean Graham reported that 30 eligible artists have applied for the Seaholm Redevelopment Parking Structure Art in Public Places project. Meghan Wells announced the Master Plan process with the Trail Foundation and the Parks Department for the south shore of the Trail. Staff distributed a newly updated Artist Resource guide about the AIPP program.
