**Dabney-Horne House, 507 W. 23<sup>rd</sup> Street**

Proposal: Terminate the restrictive covenant on the property.

Applicant: Mike McHone

City Staff: Heather Chaffin, Planning and Development Review  
Department

Staff Recommendation: Pending.

Sara Crocker spoke in support of postponement of the public hearing. Adam Schramek spoke in opposition of the postponement. The public hearing was closed on Commissioner Wolfenden-Guidry's motion; Commissioner Roberts second on a 4-0 vote (Commissioner Leary recused and off the dais).

**MOTION:** The motion to postpone the public hearing to February 24, 2014 failed on Commissioner Roberts' motion, Commissioner Galindo second on a 2-2-1 vote. Those voting aye were: Commissioners Roberts and Galindo. Those voting nay were: Commissioner Rosato and Commissioner Wolfenden-Guidry. Commissioner Leary was recused and off the dais.

**MOTION:** The motion to deny the request for postponement failed on Commissioner Wolfenden-Guidry's motion, Vice Chair Rosato second the motion on a 2-2-1 vote. Those voting aye were Commissioner Wolfenden-Guidry and Vice Chair Rosato. Those voting nay were: Commissioners Roberts and Galindo. Leary was recused and off the dais.

**COMMENTS:** Commissioner Galindo commented that she does not support the relocation of the structure. Commissioner Roberts does not support opposing the restrictive covenant. Commissioners Rosato and Wolfenden-Guidry agreed with Commissioner Roberts.

Committee Recommendation: Simply the bracket design on the addition. Removing the second front door is acceptable.

Staff Recommendation: Approve the Certificate of Appropriateness eliminating the decorative brackets on the addition and removing the non-original door.

Proposal: Replace glass block in the sidewalk in front of the building.

Committee Recommendation: Find another means to eliminate the potentially dangerous situation that does not involve the removal of the glass blocks in the sidewalk.

Staff Recommendation: Consider an alternative to removing the glass block that will maintain the historic look and provide a safer, non-slip walking surface.
