## **PROPOSAL**

Demolish a ca. 1923 converted to an apartment building with the addition of the second story in 1948.

# ARCHITECTURE

Two-story, rectangular-plan, hipped roof, frame apartment house with triple front doors, a partial-width hipped-roof independent porch on plain round wood columns, and single and double 1:1 fenestration. All windows have recently been replaced.

#### RESEARCH


The original house was built around 1923 by Dewey and Bess Ann Puryear. Dewey Puryear had a welding and radiator business for many years. It appears that around 1948, the Puryears divorced, and Mrs. Bess Glissman got the house, which she converted to an apartment building by adding the second story. The house has been an apartment house ever since. The overwhelming majority of the tenants of this house have been University of Texas students.


# STAFF COMMENTS

The house appears in the Comprehensive Cultural Resources Survey (1984) but without a priority for research.

#### STAFF RECOMMENDATION

Release the permit. The original house has been completely compromised, and there is no longer any basis for landmark designation, nor is there any justification for documenting current conditions.

# Dewey and Bess Puryear (ca 1923 – ca. 1948)

Dewey and Bess Puryear appear in the 1940 U.S. Census as the owners of this house, which was worth \$5,250. Dewey Puryear was then 41, had been born in Texas, and was the owner of a welding and radiator shop. Bess Ann Puryear was then 35, had been born in Texas, and was a book-keeper in the welding and radiator shop. They had no children listed with them. The 1930 U.S. Census shows the Puryears as the owners of this house, which was worth \$5,000. Dewey is listed as the owner of a welding and radiator shop; Bess had no occupation listed.




