Director recommended as authorized by 8-3-2 Designation of Prohibition on Alcohol

- •Within green belts
- •Within "downtown squares" not designated as event sites
- Within specified neighborhood parks
- •Within Botanical Gardens
- * Complete list provided

Director Designation considerations

- •Green belts primarily "secluded areas" are attractive to deviant behaviors
- •Downtown squares because of their location next to businesses
- · Neighborhood parks out of respect to surrounding community
- •Botanical Gardens desire to control consumption due to family use and programming elements

Alcohol Permitted

- •In parks and facilities not meeting the criteria listed in 8-3-1 Alcohol Beverages Prohibited
- •In parks and facilities not specifically designated by the director as alcohol free as authorized by 8-3-2 Designation of Prohibition on Alcohol
- Examples
- Metropolitan Parks
- District Parks
- •Zilker Clubhouse
- •Golf Courses
- Designated Event Sites

Alcohol Consumption Permitted

In accordance with 8-3-5 Temporary Sale of Beverages and Food, the Director may authorize the temporary sale, possession, or consumption of alcoholic beverages in a park or public recreation area. An authorization issued under this subsection may not exceed a 48 hour period.

In making a recommendation or decision, the director shall consider:

- (1)the impact on the surrounding neighborhood
- (2)a problem related to the sale, possession or consumption of alcohol
- (3)a clean-up agreement made by the person requesting the authorization; and
- (4) Citizen input determined relevant by the director
