Additional Backup Information

The initial authorization for the Howard Lane interlocal agreement was \$10,000,000, which was based on a conceptual project cost estimate.

The first amendment to the interlocal agreement increased the authorization to \$12,760,297.92, based on the engineer's updated construction cost estimate and an updated estimate of soft costs. This additional authorization was necessary to meet the Travis County Commissioners Court requirement for all projects that the money be appropriated before advertisement for bids.

This requested amendment will increase the authorization to \$13,218,395.93, which provides a 5% project contingency for unknown subsurface conditions and utility conflicts, and updated design costs associated with permitting revisions.

Travis County issued the Notice to Proceed to the contractor, Jordon Foster Construction, LLC, on January 13, 2014. This project is scheduled to be substantially complete within 400 calendar days.

This project is located within zip code 78660 and is managed by the Public Works Department.
