HISTORIC LANDMARK COMMISSION APRIL 28, 2014 DEMOLITION AND RELOCATION PERMITS HDP-2014-0261 802 LYDIA STREET / 1114 E. 8th STREET

PROPOSAL

Demolish a ca. 1950 house.

ARCHITECTURE

One-story, rectangular-plan, front-gabled frame house with a partial-width, front-gabled, independent porch on plain, square wood posts; 1:1 fenestration.

RESEARCH

The house appears to have been built around 1950, although no permits exist for this address. The house does not appear on the 1935 Sanborn map, and the address appears for the first time in the 1952 city directory as a house rented by Tony and Lupe Sifuentes, who lived here for only a year or two. Tony Sifuentes was a student at the time he rented this house, and he later moved to San Antonio, where he worked at Kelly Air Force Base. From around 1953 to around 1965, the house was owned and occupied by Cruz and Ignacio Galindo. Cruz Galindo operated the Casa Loma Restaurant at 800 Lydia Street (which also had an address of 1114 E. 8th Street). The 1962 Sanborn map shows the restaurant in the northeast corner of an older house, which has since been demolished. Cruz Galindo was born in Linares, Mexico, and came to the United States in 1910. He worked in restaurants in Austin, either as a cook, or as the owner, as was the case of his Casa Loma Restaurant, which he operated in the 1950s and 1960s. When he died in 1968, his death certificate showed his occupation as a retired restaurant cook. It appears that Lupe Sifuentes, the wife of Tony Sifuentes, the original occupant of this house, was Cruz Galindo's daughter.

After Cruz and Ignacio Galindo moved out of the house in the mid-1960s, it became a rental unit. In 1968, it was rented by Lincoln and Marie Thompson, who operated Lincoln and Marie's Café at the site of the Cruz Galindo's old Casa Loma at 800 Lydia Street.

STAFF COMMENTS


The house does not appear in any City survey.



BIOGRAPHICAL NOTES:

Cruz and Ignacio Galindo (ca. 1953 – ca. 1965)

The 1930 U.S. Census shows Cruz and Margaret Galindo as the renters of a house at 1105 E. 7th Street in Austin. Cruz Galindo was then 34, had been born in Mexico, and was a cook in a restaurant. He had immigrated to the United States in 1910. Margaret Galindo was then 26, had been born in Mexico, and had no occupation listed. She had immigrated to the United States in 1920. They had 4 children: Josephine, 8; Carmen, 7; Antonio, 5; and Guadalupe, 2. All of the children had been born in Texas. His 1968 death certificate notes that he had been born in Linares, Mexico, and was a retired restaurant cook.





No permits exist for the address of 802 Lydia Street.



The 1935 Sanborn map shows the site of the current house as vacant. The house at 1114 E. 8th Street (also 800 Lydia Street) is shown on the map facing 8th Street.



The 1962 Sanborn map shows the house; the house at 1114 E. 8th Street has a restaurant addition at the northeast corner of the house which was added since the time of the 1935 map above. The house has addresses of both 802 and 804 Lydia Street on this map, but the address of 804 Lydia Street has never appeared in city directories.
