Authorize award and execution of Amendment No. 4 to the contract with COPLOGIC, INC. for maintenance and support, updates and hosting for the DeskOfficer Online Reporting System (DORS) for the Austin Police Department to add three 12-month extension options in amounts not to exceed \$7,354 for the first option, \$7,722 for the second option and \$8,108 for the third option for a total contract amount not to exceed \$77,177.

Additional Backup Information

This amendment is for the continuation of maintenance, support, updates and hosting for the Coplogic, Inc. DeskOfficer Online Reporting System which was implemented by the City in the spring of 2011. This contract will add three 12-month extension options for maintenance and support for the Coplogic DeskOfficer Online Reporting System.

DORS is designed to gather information on crimes from a member of the general public (user) via a 128 bit encrypted SSL connection. The application will issue a temporary report number to the user and place the temporary report into an administrative holding area for review and modification by appropriate administrator. An email is generated to the user that the report has been submitted. The administrator logs in via a 128 bit encrypted SSL connection approves, rejects, edits or prints reports as appropriate. Rejecting a report deletes it from the system and sends an appropriate email to the citizen. Approving the report issues an official case number that is pulled from an upper-block of reserved case numbers, places it in a cue to be exported, and sends an appropriate email to the user.

The administrator can download the approved report or print the report out.

Coplogic's DeskOfficer Online Reporting System is the only citizen online reporting system that currently interfaces with the Versadex Records Management System (RMS). The DeskOfficer Online Reporting System is the wholly owned, intellectual property of Coplogic, Inc. and license, maintenance and support services for the DeskOfficer Online Reporting System is not available from any other entity.
