499,073.03 Pending Change Order # 14A - Change Orders 14A & 14B are related, and together constitute the agreement for additional work and time related to the ACM found in Holly 3 Boiler. 14A is \$499,073.03 paid from current project funds and is made up of: additional general conditions during 96 days (\$260,211.45); additional project management costs during 96 days (\$272,000); subcontractor overhead costs during 96 days (\$166,861.58); credit to Owner for delay in Substantial Completion (-\$200,000). The City also agrees to additional 96 contract days for Holly 3 Boiler ACM work. New Contract completion dates: Substantial Completion October 18, 2013 and Final Completion November 25, 2013.
