8. Digital Inclusion Strategic Plan. (Rondella Hawkins and John Speirs) (wp4)

John Speirs, Program Coordinator with the City of Austin's TARA office presented a PowerPoint on Collaborating for a Digital Austin.

On March 20, 2014 the City Manager was directed to work with the Community Technology and Telecommunication Commission (CTTC) and other relevant Commissions, community organizations and stakeholders to develop a Digital Inclusion Strategic Plan to address access and adoption of digital technology, to serve as a guiding document for providing digital inclusion opportunities in effecting the City's goal to ensure all Austin residents are served. A recommendation to City Council for consideration is due by October 23, 2014.

Mr. Speirs proposed a steering committee with stakeholders to refine principles and goals; and develop strategies created by Austin Digital Assessment (survey) Data to help develop the Digital Inclusion Strategic Plan.

Accepting staff recommendation to coordinate a steering committee to create the Digital Inclusion Strategic Plan that will be led by the Digital Inclusion Assessment (survey) Working Group which includes Commissioners McCullough, Quintanilla and White; also

including the City of Austin Innovation Officer and other community organizations was made on Commissioner Ramsey's motion; Commissioner Quintanilla's second on a vote of 6-0

9. Digital Inclusion Assessment (survey) Working Group update. (John Speirs) (wp4)

Digital Inclusion Assessment (survey) Working Group includes Commissioners McCullough, Quintanilla and White.

Mr. Speirs provided a memo and the draft survey.

The working group met with staff and UT last week to review and edit the suggested survey document.

UT will work with TARA to make sure that a statistically viable sample is maintained, but allow for the larger Austin community to ultimately be involved in the survey effort.

UT will work with TARA on utilizing undergraduate students for grassroots marketing efforts.

Stacy Bowman and Tianac Crooker were recognized for their serving on the 2014 GTOPS Grant Review Committee.

11. Update reports on networking relationships with other boards/commissions and groups, citywide and Austin Community Technology and Telecommunications Commission. (ACT&TC) information items.

Commissioner Quintanilla reported she attended the Capital Factory welcoming of the City of Austin's new Innovations Officer. The community was well represented. From this event she has some interest from the community to have a public housing tour from the Housing Authority of the City of Austin (HACA) of the learning labs in their communities.

Commission Williams reported that Austin is hosting the Broadband Summit. It's everything about gigafing America which includes infrastructure; higher broadband speed; different networking technology; customer service; and more.

Commissioner Williams is looking to the Commission to help develop a playbook for gigabit, which would include how gigabit will affect business, art, healthcare, etc.
