GENERAL CONDITIONS

GENERAL NOTES

01. CONTRACTOR SHALL ACQUAINT HIM OR HERSELF WITH ALL OWNER REQUIREMENTS AND SHALL COMPLY FULLY WITH SUCH REQUIREMENTS.

02. BEFORE SUBMITTING BID, CONTRACTOR AND ALL SUBCONTRACTORS SHALL VISIT THE SITE AND VERIFY ANY AND ALL CONDITIONS AND ITEMS AS MAY BE DEEMED NECESSARY FOR THE CONSTRUCTION OF THIS PROJECT, WHETHER OR NOT SHOWN IN THESE PLANS.

03. CONTRACTOR SHALL COORDINATE HIS OR HER WORK WITH ALL OTHER CONTRACTORS FURNISHING THE LABOR, MATERIALS, AND ALL WORK, SO THAT THE WORK AS A WHOLE SHALL BE EXECUTED AND COMPLETED WITHOUT CONFLICT OR DELAY.

04. ALL MATERIALS FURNISHED ALL INSTALLED UNDER THIS CONTRACT SHALL BE NEW, FREE FROM ALL DEFECTS, AND SHALL BE GUARANTEED FOR A PERIOD OF ONE (1) YEAR FROM DATE OF ACCEPTANCE OF WORK. SHOULD DEFECTS DEVELOP DURING THIS PERIOD DUE TO DEFECTIVE MATERIAL OR FAULTY WORKMANSHIP, CONTRACTOR AND ALL SUBCONTRACTORS SHALL REMEDIATE SAME WITHOUT COST TO OWNER, ANY DEFECTS EVIDENT AT THE TIME OF INSTALLATION SHALL BE CORRECTED IMMEDIATELY TO THE SATISFACTION OF OWNER.

05. IT SHALL BE RESPONSIBILITY OF THE CONTRACTOR TO ACQUAINT HIMSELF WITH THE DIMENSION OF ALL EQUIPMENT INCLUDED IN THIS PROJECT SO THAT PREPARATIONS CAN BE MADE TO PROVIDE ENTRY INTO THE SPACE WITH SUFFICIENT CLEARANCE, AND TO INSURE THAT ADEQUATE FLOOR SPACE IS AVAILABLE LS, ETC.

06. REVIEW THE CONSTRUCTION DOCUMENTS AT THE JOB SITE TO VERIFY ALL DIMENSIONS AND CONDITIONS. THE CONTRACTOR IS RESPONSIBLE FOR NOTIFYING DESIGNER OF ANY OMISSION, DISCREPANCIES AND/OR CONFLICTS WITH EXISTING CONSTRUCTION. NO ALLOWANCE SHALL BE MADE FOR EXTRA EXPENSE OR TIME DUE TO CONTRACTOR'S FAILURE OR NEGLIGENCE TO COMPLETE EXAMINATION OF JOB SITE.

07. ALL WORK SHALL BE PERFORMED IN STRICT COMPLIANCE WITH ALL.

08. APPLICABLE CODES AND LOCAL ORDINANCES INCLUDING ADA. THE GENERAL CONTRACTOR NOR ANY SUB-CONTRACTOR SHALL NOT USE ANY ASBESTOS OR ASBESTOS CONTAINING MATERIALS IN ANY AREA OF THE CONSTRUCTION.

09. OBTAIN ALL APPLICATIONS, PERMITS, INSPECTIONS, ETC. REQUIRED TO COMPLETE THIS WORK.

10. PROVIDE AND INSTALL EXIT LIGHTS AS REQUIRED BY LOCAL CODES AND/OR AS DIRECTED BY THE FIRE MARSHAL. RE: ELECTRICAL.

11. THESE DRAWINGS SHALL NOT BE USED FOR CONSTRUCTION UNLESS DATED AND NOTED AS ISSUED FOR CONSTRUCTION.*

12. DO NOT SCALE DRAWINGS, DIMENSIONS GOVERN. LARGE SCALE DETAIL DRAWINGS COVER OVER SMALL SCALE DETAIL DRAWINGS. CONTACT DESIGNER FOR DIMENSIONAL DISCREPANCY CLARIFICATION.

13. PARTITIONS, MILLWORK, ETC. WHICH DO NOT HAVE DIMENSION SHOWN ARE FREE-FLOATING AND SHOULD BE VERIFIED FOR DIMENSIONS IN THE FIELD.

14. SUBMIT TO DESIGNER, FOR REVIEW PRIOR TO CONSTRUCTION, ALL REQUIRED SHOP DRAWINGS, PRODUCT DATA AND SAMPLES. SUBMITTALS INCLUDE, BUT ARE NOT LIMITED TO:
A. SHOP DRAWINGS FOR ALL MILLWORK AND WOOD CONSTRUCTION, ALUMINUM EXTRUSIONS AND BREAK METAL, INTERIOR GLAZING AND GLASS DOORS, AND DETAILS FOR ALL AIR SUPPLY AND RETURN REGISTERS MOUNTED IN GYPSUM BOARD SURFACES.
B. PRODUCT DATA OR CUT SHEETS OF HARDWARE, APPLIANCES, PROJECTOR SCREENS, SUPPLY AND RETURN REGISTERS, LIGHT FIXTURES, AND PLUMBING FIXTURES AND FITTINGS.
C. SAMPLES OF ALL FLOOR, CEILING, WALL, MILLWORK, DOOR, AND HARDWARE FINISHES.

15. PROVIDE TEMPORARY POWER FOR SMALL TOOLS AND LIGHTING FOLLOWING O.S.H.A. REQUIREMENTS. DO NOT TAP INTO OTHER ELECTRICAL METERS.

16. WHERE NEW WORK CONNECTS WITH EXISTING, DO NECESSARY CUTTING, FITTING AND PATCHING. FURNISHING ALL LABOR AND MATERIALS NECESSARY TO COMPLETE THE WORK AND PROJECT ALL EXISTING WORK FROM DAMAGE.

17. CALL DESIGNER WHEN BUILD-OUT IS SUBSTANTIALLY COMPLETE, SO THAT AN INSPECTION AND PUNCH LIST MAY BE PREPARED PRIOR TO OCCUPANCY.

18. PROJECT SHALL BE PROFESSIONALLY CLEANED AFTER COMPLETION OF WORK

19. ALL WORK SHALL CONFORM TO THE REQUIREMENTS OF ALL LOCAL LAWS, RULES AND REGULATIONS OF ALL LEGALLY CONSTITUTED PUBLIC AUTHORITIES HAVING JURISDICTION. IN CASES OF CONFLICT BETWEEN REQUIREMENTS, THE MOST RESTRICTIVE SHALL APPLY.

20. CONTRACTOR SHALL PROVIDE ADEQUATE PROTECTION OF WORK, MATERIALS, FIXTURES, ETC. FROM LOSS, DAMAGE, FIRE, THEFT, ETC.

21. WHEREVER THE TERM "OR EQUAL" IS USED, IT SHALL MEAN EQUIVALENT PRODUCT AS APPROVED IN WRITING BY DESIGNER.

DEMOLITION

01. ALL DEMOLITION SHALL BE DONE NEATLY AND WITHOUT DAMAGE TO THE REMAINING CONSTRUCTION. THE AREA SHALL BE CLEAR OF ALL DEBRIS, FLOOR COVERING AND ADHESIVE RESIDUE, ETC. AND LEFT CLEAN.

02. WHERE SLAB DEMOLITION OCCURS NEAR AN OCCUPIED TENANT SPACE, WORK MUST BE DONE DURING NON-BUSINESS HOURS, UNLESS APPROVED IN ADVANCE BY THE LANDLORD.
A. WHEN BREAKING OUT THE SLAB FOR ON-GRADE FLOORS, ALL EXCAVATED AREAS IN THE BUILDING PAD ARE TO BE BACK-FILLED WITH SAND, COMPACTED IN 8" LIFTS BY HAND TAMPING OR WITH A MECHANICAL TAMPING MACHINE; NEW REINFORCING SHALL BE EQUAL TO EXISTING SLAB REINFORCED AND SHALL BE OVERLAPPED AND TIED TO THE EXISTING REINFORCING THIRTY BAR DIAMETERS. RE-POUR BREAKOUT AREA OVER 6 MIL. VAPOR BARRIER WITH 3,000 PSI CONCRETE TO THE SAME DEPTH AS THE EXISTING SLAB.

03. CUT HOLES IN CONCRETE FOR PIPING, ETC. WITH APPROPRIATE TOOLS TO ASSURE AN EVEN CUT WITH CLEAN EDGES. HOLES WILL NOT BE LARGER THAN NECESSARY TO ALLOW PIPE TO FIT THROUGH. ANY HOLES THAT MAY AFFECT THE STRUCTURAL INTEGRITY OF THE FACILITY MUST BE APPROVED IN WRITING BY THE STRUCTURAL ENGINEER. SEAL ALL PIPES WITH TREMCO, INC. MONO SEALANT OR APPROVAL EQUAL.

04. REMOVE ALL ABANDONED CABLE FROM PLENUM.

05. CONTRACTOR SHALL VERIFY EXISTING CONDITIONS AND EFFECT ALL ALTERATIONS AND MODIFICATIONS NECESSARY TO DELIVER COMPLETE PROJECT INSTALLATIONS TO CONFORM TO CONTRACT DRAWINGS AND SPECIFICATIONS.

PARTITIONS & DRYWALL CONSTRUCTION

01. DRYWALL FRAMING SHALL BE MINIMUM 25 GAUGE GALVANIZED METAL STUDS, UNLESS NOTED OTHERWISE.

02. ALL DRYWALL CONSTRUCTION SHALL BE TAPED AND FLOATED PRIOR TO RECEIVING SCHEDULES FINISH. ALL OUTSIDE CORNERS SHALL RECEIVE METAL CORNER BEAD, UNLESS NOTED OTHERWISE, AND BE FLOATED SMOOTH.

03. PROVIDE RATED DAMPERS AS REQUIRED AT PARTITIONS WHICH EXTEND ABOVE THE CEILING, THROUGH THE RETURN AIR PLENUM TO THE UNDERSIDE OF STRUCTURE WHERE PARTITIONS ARE NOTED TO HAVE A STC ACOUSTICAL RATING. SOUND ATTENUATION DAMPER SHALL BE ADDED AT THESE PENETRATIONS.

04. TYPICALLY, PARTITIONS WHICH TERMINATE AT THE EXTERIOR WALL SHALL BE CENTERED ON THE CENTER LINE OF A WINDOW MULLION, CENTER LINE OF A COLUMN, OR ALIGN WITH FACE OF A COLUMN.

05. TYPICALLY, PARTITIONS WHICH ALIGN WITH EXISTING GYPSUM BOARD CONSTRUCTION SHALL ALIGN FINISHED FACE OF A NEW GYPSUM BOARD WITH FINISHED FACE OF EXISTING. REMOVE CORNER BEAD AND FLOAT SMOOTH TO EXISTING CONSTRUCTION, UNLESS DETAILED OTHERWISE.

06. INSTALL GLAZING IN ACCORDANCE WITH MANUFACTURER'S RECOMMENDATIONS. REPLACE CRACKED, SCRATCHED, BROKEN OR OTHERWISE DAMAGED GLASS. REMOVE ADHERED MATTER FROM GLAZING MATERIAL.

07. CONTRACTOR SHALL PROVIDE ALL NECESSARY BRACING TO STRUCTURE FOR INTERIOR PARTITIONS, CEILING, PLATFORMS, ETC., WHETHER SHOWN ON DRAWINGS OR NOT.

08. PROVIDE SILICONE SEALANT AT ALL JOINTS AND INTERFACES OF ALL EQUIPMENT, WALLS, ETC.

FINISHES

01. CONFIRM THAT MATERIAL USED FOR INTERIOR WALL AND CEILING FINISHES MEET OR EXCEED THE FOLLOWING FLAME SPREAD RATING:
A. ENCLOSED VERTICAL EXIT WAYS
CLASS I OR A, 0-25
B. OTHER EXIT WAYS
CLASS II OR B, 26-75
C. ROOMS & OTHER AREAS
CLASS III OR C, 76-200
FINISHES MAY BE DOWN RATED ONE CLASS WHEN AN AUTOMATIC SPRINKLER SYSTEM IS PROVIDED.

02. PREPARE ALL SURFACE RECEIVING FINISHES IN ACCORDANCE WITH FINISH MANUFACTURE'S RECOMMENDATIONS. ALL FINISHED AND ADJOINING SURFACES SHALL REMAIN FREE OF GLUE, PLASTER OR PAINT EXCESS.

03. TRANSITIONS BETWEEN WALL COVERING AND PAINT WHICH OCCUR AT OUTSIDE CORNERS SHALL BE FINISHED WITH A TUCK-IN-METAL BEADING UNLESS DETAILED OTHERWISE.

04. ROUGH FLOOR TO BE PATCHED AND/OR LEVELING MATERIALS AND PROCEDURES. RECEIVE INDICATED FLOOR FINISHES. FOLLOW FLOOR FINISH MANUFACTURER'S RECOMMENDED PATCHING/LEVELING MATERIALS AND PROCEDURES.

05. ALL CARPET WITHIN THIS LEASE SHALL BE "DIRECT GLUE DOWN" INSTALLATION, UNLESS NOTED OTHERWISE.

06. FLOOR FINISH TRANSITIONS SHALL OCCUR AT THE CENTER LINE OF THE DOOR, UNLESS NOTED OTHERWISE.

07. TRANSITIONS BETWEEN CARPET AND V.C.T. SHALL OCCUR WITH VINYL REDUCER TRANSITION.

08. RUBBER OR VINYL BASE SHALL BE BEVELED, NOT WRAPPED, AT INSIDE CORNERS.

09. CONTRACTOR TO PROVIDE MAINTENANCE/CARE INSTRUCTIONS FOR ALL INTERIOR/SPECIAL; FINISHES.

10. DIMENSIONS IN FLOOR PLANS AND SECTIONS ARE TO FACE OF FINISH UNLESS NOTED OTHERWISE, DIMENSIONS ON REFLECTED CEILING PLANS ARE TO FINISHED FACE UNLESS NOTED OTHERWISE.

ENGINEERING

01. LABEL ELECTRICAL PANELS, CONTROL POINTS, SWITCHES, AND MOTORS IDENTIFY PANEL BY NUMBER. LABEL SWITCHES INDICATING THE EQUIPMENT WHICH THEY CONTROL.

02. RECORD ALL CIRCUITS AND CIRCUIT NUMBERS ON AS-BUILT DRAWINGS AND LABEL ALL CIRCUITS ON PANEL DIRECTORIES. FIELD VERIFY BRANCH CIRCUIT AVAILABILITY.

03. VERIFY VOLTAGE OF ALL LIGHTING FIXTURES SPECIFIED TO ASSURE COMPATIBILITY WITH VOLTAGE SUPPLIED TO DEMISED SPACE.

04. IF ANY ELECTRICAL CORE THROUGH SLAB CAN NOT BE LOCATED IN THE EXACT DIMENSION LOCATION, NOTIFY DESIGNER BEFORE PROCEEDING.

05. COORDINATE ELECTRICAL WORK WITH MILLWORK FOR ELECTRICAL SWITCHES, OUTLETS OR DEVICES LOCATED WITHIN THE MILLWORK.

06. MOUNTING HEIGHTS INDICATED ARE TO THE CENTER OF OUTLET. ALL WALL OUTLETS SHALL BE MOUNTED 18" TO CENTER OF OUTLET ABOVE FINISHED FLOOR, UNLESS NOTED OTHERWISE. GENERAL CONTRACTOR TO VERIFY SLAB VARIATIONS AND INSURE CONSISTENT MOUNTING HEIGHT FOR ALL DEVICES WITHIN THE SAME SPACE.

07. ALL LIGHT SWITCHES AND THERMOSTATS SHALL BE MOUNTED 48" ABOVE FINISHED FLOOR, UNLESS OTHERWISE NOTED.

08. ELECTRICAL OUTLETS AND/OR SWITCHES ON OPPOSITE SIDES OF A COMMON WALL SHALL BE LOCATED IN SEPARATE STUD CAVITIES. NO BACK-TO-BACK OUTLETS SHALL BE PERMITTED. WHERE SPECIFIC DIMENSIONS CONTRADICT THIS NOTE, RELOCATE ONE OUTLET OR SWITCH TO THE OPPOSITE SIDE OF THE STUD WHICH IS NEAREST THE GIVEN DIMENSION.

09. NOTIFY DESIGNER FOR APPROVAL TO RELOCATE FIXTURES WHERE CLEARANCE PROBLEMS ARISE IN THE LOCATION AND/OR RELOCATION OF CEILING MOUNTED DEVICES, SHOWN ON THE DRAWINGS.

10. GANG ADJACENT SWITCHES AND/OR OUTLETS TOGETHER AND LOCATE UNDER A SINGLE COVER PLATE.

11. PROVIDE INDUSTRY STANDARD ORANGE RECEPTACLES FOR OUTLETS WITH DEDICATED CIRCUITS, AND YELLOW RECEPTACLES FOR OUTLETS WITH ISOLATED GROUND.

ENGINEERING CONT.

12. INSTALLATION OF WALL TELEPHONE OUTLET AND WIRING OF ALL TELEPHONES SHALL BE BY THE TENANT.

13. WHERE SPECIAL OUTLET TYPES AND/OR POWER REQUIREMENTS ARE SCHEDULED AND SPECIFICATIONS ARE NOT PROVIDED, COORDINATE REQUIREMENTS WITH OWNERS.

14. ELECTRICAL SWITCHES AND COVER PLATES TO BE DECOR/WHITE U.N.O. DATA CONNECTION DEVICES AND COVER PLATES ARE TO BE WHITE U.N.O., WHERE DEVICES ARE LOCATED IN/ON CLEAR FINISH MILLWORK OR DARK COLOR LAMINATE OR WALL FINISH, VERIFY W/DESIGNER ALTERNATE DEVICE COLOR (IVORY, BROWN, BLACK).

15. PROVIDE CONCEALED ACCESS PANELS AT ALL LOCATIONS WHICH MAY REQUIRE SERVICING ACCESS TO ANY VALVES, CLEAN OUTS, DAMPERS, A/C UNITS, ETC. SUBMIT SAMPLES AND LOCATION TO KMDIS FOR APPROVAL.

16. GENERAL CONTRACTOR TO COORDINATE HARDWIRE CONNECTION OF FURNITURE SYSTEM WHIPS TO FURNITURE POWER DEVICE BETWEEN ELECTRICAL AND FURNITURE VENDOR.

20. CONTRACTOR SHALL INSTALL ALL LAMPS IN LIGHTING FIXTURES. LAMPS SHALL BE GUARANTEED FOR A PERIOD OF ONE (1) MONTH FROM THE DATE OF ACCEPTANCE OF WORK UNLESS OTHERWISE NOTED ON THE PLANS.

CONTRACTOR ALERT

01. THE CONTRACTOR SHALL ADHERE TO THE DRAWINGS AND SPECIFICATIONS. SHOULD ANY ERROR OR INCONSISTENCY APPEAR REGARDING THE TRUE MEANING AND/OR INTENT OF THE DRAWINGS OR SPECIFICATIONS, THE CONTRACTOR SHALL IMMEDIATELY REPORT SAME TO THE DESIGNER WHO WILL MAKE ANY NECESSARY CLARIFICATION/INTERPRETATION, OR REVISION REQUIRED.

02. IF THE CONTRACTOR PROCEEDS WITH THE WORK WITHOUT NOTIFYING THE DESIGNER OF ANY SUCH DISCREPANCIES. HE OR SHE SHALL ASSUME ALL CHARGES AND MAKE ANY CHANGES TO HIS OR HER WORK MADE NECESSARY BY HIS FAILURE TO OBSERVE AND/OR REPORT THE CONDITION.

03. NO SUBSTITUTIONS WILL BE ALLOWED FOR THE GENERAL OR SUB CONTRACTOR'S FAILURE TO PLACE TIMELY ORDERS ON PROPRIETARY SPECIFICATIONS.

04. CONTACT DESIGNER FOR CLARIFICATION REGARDING ANY CONFLICT WITHIN THIS SET OF DRAWINGS.

05. SUBCONTRACTORS ARE REQUIRED TO BASE THEIR BIDS ON REVIEW OF FULL SETS OF DRAWINGS.

06. AN AUTOMATIC SUPPRESSION SYSTEM WILL BE INSTALLED TO PROTECT THE KITCHEN COOKING EQUIPMENT. THIS WILL BE ADDRESSED IN A SEPARATE PERMIT THROUGH A DEFERRED SUBMITTAL.

ROUGH CARPENTRY & BLOCKING

01. ALL ROUGH CARPENTRY TO BE SOUTHERN PINE OR DOUGLAS FIR, GRADE NUMBER (2) OR EQUAL.

02. ALL NAILERS, BLOCKING, GROUNDS, ROUGH BLOCKS AND MISCELLANEOUS BLOCKING SHALL BE FIREPROOFED IN ACCORDANCE WITH MUNICIPAL CODE, AND ALL OTHER APPLICABLE CODES.

03. PROVIDE REQUIRED BRACING AND BLOCKING IN PARTITIONS WHICH ARE TO RECEIVE MILLWORK, SHELVING, ETC.

04. PLACE WALL HUNG FIXTURES ON PARTITIONS REINFORCED WITH FIXTURE CHAIRS, CARRIERS, OR OTHER HEAVY DUTY REINFORCEMENTS. SECURELY FASTEN WALL HUNG FIXTURES.

05. CONTRACTOR SHALL NEVER SCALE DRAWINGS. LOCATIONS FOR ALL PARTITIONS, WALL, CEILINGS, ETC. WILL BE DETERMINED BY DIMENSIONS ON THE DRAWINGS. ANT SUCH DIMENSIONS MISSING FROM THE PLANS MUST BE BROUGHT TO THE ATTENTION OF THE DESIGNER IMMEDIATELY.

FINISHED MILLWORK & CABINETS

01. ALL WOODWORK SHALL COMPLY WITH THE APPLICABLE REQUIREMENTS OF THE "QUALITY STANDARDS" OF THE ARCHITECTURAL WOODWORK INSTITUTE (A.W.I.) ANY REFERENCE TO THE PREMIUM, CUSTOM OR ECONOMY GRADE SHALL BE DEFINED IN THE LATEST EDITION OF THE A.W.I. "QUALITY STANDARDS." ANY ITEM ON A GIVEN SPECIFIC QUALITY GRADE, SHALL BE CUSTOM GRADE.

02. COORDINATE MILLWORK AND CABINETS WITH OTHER TRADES BEFORE INSTALLATION. THE CABINET SUBCONTRACTOR IS TO JOB VERIFY ALL DIMENSIONS BEFORE INSTALLATION. VERIFY EQUIPMENT SIZES AND SPECIFICATIONS BEFORE FABRICATION AND/OR INSTALLATION.

03. ALL WOOD SURFACES NOT RECEIVING PAINT, PLASTIC LAMINATE, OR OTHER FINISH, SHALL BE SEALED BE SEALED TO PREVENT MOISTURE PENETRATION.

INSULATION & FIRE SAFETY

02. INSTALL FIRE SAFETY INSULATION, AS REQUIRED BY CODE AND IN ACCORDANCE WITH MANUFACTURER'S RECOMMENDATIONS, AFTER MECHANICAL AND ELECTRICAL SERVICES HAVE BEEN INSTALLED.
