1. CITIZEN COMMUNICATION: GENERAL

Tracy Witte- Central East Austin – HCCA decline of information, meeting cancellations, lack of notification to residents and neighborhood groups regarding Rosewood Courts- density issues, Downtown Austin plan

2. APPROVAL OF MINUTES

a) Approval of the June 19, 2013 Meeting Minutes-Motion to approve the June 19, 2013 minutes was made by Commissioner Nortey, seconded by Commissioner Stevens, and approved on a vote of 2-0. Commissioner Chimenti was absent.

a. Rio Lado Apartments Redevelopment—Ron Kowal, VP for the Austin Affordable Housing Corporation, will provide an update on redevelopment plans near the Rio Lado apartments.

Affordability at Mueller—Kelly Weiss, Executive Director of Habitat for Humanity, will discuss
the issue, including how affordable prices are advertised and what happens to affordable
homes when they are resold.

4. **NEW BUSINESS**

a. Article 16, Neighborhood Plan Amendments—Stevie Greathouse, Principal Planner, requests a discussion with the subcommittee on forwarding the amendments to Article 16 to Opticos and as part of the Land Development Code rewrite, rather than taking the amendment as a single item to City Council.

A motion was made by Commissioner Nortey to approve the withdrawal of sending the amendment as a single item to City Council and move to the code rewrite commission, with a full vote before the Planning Commission, seconded by Commissioner Stevens, on a 2-0 vote. Commissioner Chimenti was absent.
