Subject

Approve an ordinance authorizing acceptance of \$401,881 in grant funds from the U.S. DEPARTMENT OF HEALTH AND HUMAN SERVICES, HEALTH RESOURCES AND SERVICES ADMINISTRATION, and amending the Fiscal Year 2013-2014 Health and Human Services Department Operating Budget Special Revenue Fund (Ordinance No. 20130909-001) to appropriate \$401,881 for the Ryan White Part A HIV Emergency Relief Project and Minority AIDS Initiative Grant Program that provides medical and supportive services to people with the human immunodeficiency virus.

Amount and Source of Funding

Funding in the amount of \$401,881 is available from the U.S. Department of Health and Human Services (DHHS), Health Resources and Services Administration (HRSA). The grant period is from March 1, 2014 through February 28, 2015. No City match is required.

Additional Backup Information

On April 28, 2014, the City of Austin Health and Human Services Department (HHSD) received a second notice for the Grant Award from the U.S. Department of Health and Human Services for the Ryan White Part A HIV Emergency Relief Project and MAI for the period of March 1, 2014 through February 28, 2015. The current FY2013-14 appropriation Budget is \$4,085,000. The requested increase of \$401,881 represents the difference between the grant appropriation of \$4,085,000 and the grant award amount of \$4,486,881. The additional grant funds are a result of Ryan White Part A and MAI grant increase.

The Austin Transitional Grant Area plan to use the grant funds for direct HIV core and support services listed on Attachment A.

Services are delivered by our Ryan White Part A providers that include: AIDS Services of Austin, Inc., Austin/Travis County Mental Health Mental Retardation C.A.R.E. Program, Community Action, Inc. of Central Texas, David Powell Community Health Center, Project Transitions, Inc., Waterloo Counseling Center, Wright House Wellness Center, as well as Communicable Disease Unit, via an intradepartmental agreement with the Disease Prevention and Health Promotion Division. The General Fund will not be required to contribute to this grant.
