## To whom it may concern:

I am a 40 year resident of the neighborhood adjoining Ski Shores restaurant. I own a single family residence within 600 ft of Ski Shores.

I am asking for the City Council to again review the decision to issue a permit to allow outdoor music to be played 74 hours a week.

In the many years of living here I have called the City of Austin police, the Lake Patrol, the Travis county Sheriff's office, in an attempt to keep, the volume reduced, or the hours of playing reduced to something reasonable. I have driven down to the restaurant and asked the owner to come up to my home, with all doors and windows closed - he too acknowledged the volume was too high.

I have called Ski Shore 100 plus times and asked them to turn down the music. In the last few years I contacted one of the new owners Rick Engel and appealed to him to do something about the noise level.

I even offered to pay part of the costs to install sound curtains, or directional speakers.

## Nothing changes.

Ski Shores elevates the sound levels way above 70 decibels
Ski Shores stays open after hours and continues to play music past 10:00 pm
Austin police are too busy on Friday or Saturday nights to bring their decibel meter to monitor the levels.

We are captives in our own homes, forced to listen to music we did not choose even with our a/c running and all windows and doors closed.
