## **Boards and Commissions Survey**

The resolution directs the following:

- Direct the City Clerk to bring an ordinance implementing the recommendations of Section1 of the Transition Taskforce Report. For details of Section 1, please see pages 6-7 of the report.
- Direct the City Manager to post a public hearing at the August 7<sup>th</sup> Council meeting regarding Sections 2-4 of the Transition Taskforce Report.
- The resolution also directed the Clerk's office to solicit feedback from all BC members prior to the public hearing.

If a Board or Commission chooses to provide feedback as a group, the staff liaison will respond to the online survey based on feedback provided at the meeting by entering comments in response to the 4 sections detailed below:

**Section 1. Transition Work Group:** This section consists of the Transition Plan, which provides recommendations for a transitional period to allow the new Council to nominate members and allows the new members an opportunity to complete training and be brought up to speed on issues facing their commission. It also provides recommendations on potential updates to Chapter 2-1 that apply to all boards and commissions.
