# A. CALL TO ORDER

Chair Fishbeck called the meeting to order at 6:04 p.m.

#### **B. CITIZEN COMMUNICATION**

Bill Oakey urged the Committee to recommend to the City Council to transfer the City's \$14.2 million budget surplus to the Water Utility to help the financial position of the utility. Mr. Oakey stated he brought up the subject of the transfer recently to the Council on Citizens Communication and Mayor Lee Leffingwell expressed an interest in pursuing the proposal. Mr. Oakey remarked on the memorandum from City Manager Marc Ott that identified 900 staff vacancies as of January 10th of this year and he suggested unfilled

positions had a probability of generating an additional money surplus in the City's budget and suggested this too, should be transferred to the Water Utility.

## C. APPROVAL OF MINUTES

Brian Rodgers moved to approve the minutes contingent on the removal of Chair Mickey Fishbeck designated as absent. Luke Metzger 2<sup>nd</sup> the motion to approve them. Chair Fishbeck, Vice-chair Bailey, Commissioner Kelly, Committee Member Rodgers, Commissioner Metzger, and Commissioner Kidwell approved the minutes. Commissioner Lee was absent.

Both Mr. Meszaros and Mr. Anders answered several questions from the Commissioners regarding reduction option items and the impact on the Utility's debt coverage, revenue and possible water rate increase.
