# HISTORIC LANDMARK COMMISSION JULY 14, 2014 DEMOLITION AND RELOCATION PERMITS HDP-2014-0408 1612 WILLOW STREET

#### **PROPOSAL**

Demolish a ca. 1906 house.

#### ARCHITECTURE

One-story, wing-and-gable plan, frame house with board-and-batten siding, fishscale imbrication in the tympanum of the gable, and an in-filled front porch; single 1:1 fenestration.

#### RESEARCH

The house was built around 1906; the first occupant of the house was Charles M. Willis, who had lived down the street on Willow prior to moving into this house, and who, after living here, moved across the street. Willis was a watchmaker who worked for John A. Jackson, a pawn broker, jeweler, and diamond merchant on Congress Avenue, and when he moved across the street to 1613 Willow Street, he had opened his own watchmaking and jewelry business at 109 W. 6th Street. Willis lived here until around 1912. A carpenter, J. Ira Pearce, is listed as the occupant in the 1912-13 city directory. Beginning around 1914, the Hinojosa (or de Hinojosa) family rented the house. Jose Hinojosa was listed as a bartender living at 909 Comal Street in the 1912-13 city directory. By 1914, he and his family, which included his mother, Francisca R. Hinojosa, a widow, several brothers: Entimio, a laborer, Isaac, a laborer, and Florencio, who was a confectioner and fruit seller, as well as a sister, Virginia, who never had an occupation listed in the city directories. The Hinojosa family lived here until around 1934.

The house was rented to Anglo families through the mid-1950s; the tenants included a laborer for International Harvester, a laborer, and a painter. From the mid-1950s, the house was occupied by Pascual G. and Guadalupe Beza, who initially rented the house, and purchased it around 1970. Pascual Beza was a clerk at the State Department of Parks and Wildlife; Guadalupe Beza worked as a nursery school teacher and as a homemaker for the State Department of Public Welfare.


#### STAFF COMMENTS

Initiate a historic zoning case to investigate and evaluate alternatives to demolition. This is a relatively intact house in a historic area of East Austin, and every effort should be made to preserve the house if possible.

#### **BIOGRAPHICAL NOTES**

Charles M. Willis (ca. 1906 – ca. 1912)

Samuel T. Hamby (ca. 1906 – ca. 1909)

Very little is currently known about Charles M. Willis at this point, except that he was the first resident of this house, had live on Willow Street before moving in here, and moved across the street to another house on Willow Street around 1912. He shared this house with Samuel Hamby from 1906 to around 1909.

Samuel Hamby appears in the 1900 U.S. Census for Webb County, Texas as the 24-year old son of Charles and Sarah Hamby. Charles Hamby was a dairy man; Samuel Hamby is also listed as a dairyman. The 1910 U.S. Census shows Sam and Estelle Hamby living in San Antonio where Sam was a stationery engineer. By 1920, Sam and Estelle Hamby were living in Houston with Estelle's brother; Sam was a stationery engineer for an oil company. The 1930 U.S. Census shows Sam and Estelle as farmers in rural Travis County. They had no children.

#### SAMUEL T. HAMBY

Samuel Thomas Hamby, 76, long-time Austin resident died in a local hospital Saturday. He was a member of the Methodost Church. Cade Rothwell Masonic Lodge 1151 at Houston and Woodmen of the World, Are Hamby died in 1944. Funesal services will be held at Weed-Corley Funeral Home Monday at 10 a. m. with Rev. J. Leonard Rea officiating. Burial will be in Oakwood Cemetery under auspices of Austin Lodge 12,

#### Frances, Florencio, and Virginia Hinojosa (ca. 1913 – ca. 1934)

Frances Hinojosa appears as the renter of this house in the 1920 U.S. Census. She was a 61-year old Mexican-born widow with no occupation listed. With her lived three of her children: Entimio, 40, a Mexican-born proprietor of a fruit stand; Florencio, 37, a Mexican-born proprietor of a fruit stand; and Virginia, 28, who had been born in Mexico, and had no occupation listed. Frances Hinojosa died in 1929; there was no obituary in the Austin newspapers.

The 1930 U.S. Census shows Florencio Hinojosa as the renter of this house. He was the proprietor of a fruit and cold drink stand. With him lived a sister [?], Isaac, 49,who had been born in Mexico and had no occupation listed; a brother, Jose, 41, a self-employed truck driver; and a sister, Virginia, 37, who had no occupation listed. By 1940, according to the U.S. Census, the Hinojosas were living down the street at 1608 Willow Street. Both Florencio and Jose were laborers for the a construction company. Neither Virginia nor Isaac had an occupation listed.

#### Herman J. and Esther Fuchs (ca. 1940 – ca. 1942)

Herman and Ester Fuchs appear in the 1940 U.S. Census as the renters of this house. Herman Fuchs was a 32-year old Texas-born laborer at Marshall Ford Dam, who had lived in rural Washington County, Texas in 1935. Ester Fuchs was also 32, had been born in Texas, and had lived in rural Fayette County, Texas in 1935. They had 2 daughters: Delores, 6, and Clarice, 4.

Pascual and Guadalupe Beza, Jr. (ca. 1957 - )
