


FY 14 YTD Car Wash Breakdown

FY 14 YTD Irrigation Program








Weather outlook



- Another hot, dry summer is expected
- Recent rains have lessened chances of falling below 600,000 AF this year
- Lake levels not this high since April 2013
- El Nino could bring drought relief this Fall

Highland Lakes Storage *



^{*} Based on persistent dry conditions and emergency drought relief measures affirmed by TCEQ on Feb. 26, April 30, and June 4, 2014, and additional emergency relief suspending releases of interruptible stored water for customers in the Gulf Coast, Lakeside and Pierce Ranch irrigation operations through the end of the irrigation season.


Stage 2 remains in place





- Combined storage currently at 780,000 AF (39%)
- Stage 2 (1 day per week watering) in effect since September 4, 2012
- Stage 3 trigger possible this Fall if severe drought conditions persist
