PROPOSAL

Demolish a ca. 1906 house.

ARCHITECTURE

One-story, wing-and-gable plan, stone-veneered, frame house with a partial-width inset porch on metal supports. Paired 2:2 fenestration.

RESEARCH

The house was built around 1906. The first known owners and occupants were Eugene B. and Maggie Jones. Eugene B. Jones was the Travis County road superintendent. He and Maggie lived here until around 1910. The house had several short-term occupants until around 1921, when it was purchased by a widow, Sallie M. Badger, who lived here until her death in 1936. The house was again a rental property through the mid-1940s, when it was purchased by Carl and Dorothy Barho. Carl Barho was a painter, who later became a general contractor. Their daughter, Annie, married Arnold L. Cain, and the Cains moved into this house around 1954, when her parents moved to another house on El Paso Street. Arnold Cain had been married before, and was a cafeteria cook. By the time he married Annie Barho, he was a fireman and later an engineer for the Southern Pacific Railroad. After Arnold's death in 1982, Annie Cain continued to live here for several years.


STAFF COMMENTS

The house does not appear in any City survey.

STAFF RECOMMENDATION

Encourage rehabilitation and re-use of the house if feasible. While the house has been significantly modified with the application of a stone veneer (at some time prior to 1962), it retains its essential form and context within this potential historic district, and could possibly be restored to its historic appearance. This is one of the earliest houses on Eva Street, and this is a block that is remarkably intact with houses dating from the early years of the 20th century; if rehabilitation and re-use of this house is not feasible, then staff strongly encourages the applicant to consider the architectural context of the neighborhood and to construct a new house that is compatible with the style and scale of the adjacent houses.

BIOGRAPHICAL NOTES

Eugene B. Jones (ca. 1905 – ca. 1910)

Eugene B. and Maggie Jones appear in the 1900 U.S. Census for rural Travis County; they lived on a rented farm. Eugene B. Jones was 26, had been born in Texas, and was listed as a farmer. Maggie Jones was 29, had been born in Texas, and had no occupation listed. They had 3 children: Raymond, 6; Hubert, 4; and Bessie, 2.

The 1910 U.S. Census shows the Jones family living in a rented house on South Congress Avenue; the house was not numbered. Eugene Jones was listed as the superintendent of

county roads. In addition to the children noted in the 1900 U.S. Census, there was another son, Rufus, 6.

Sallie Badger is listed in the 1930 U.S. Census as the owner of this house, which was worth \$1,500. She was 78, had been born in Missouri, and had no occupation listed. She lived by herself.

Charles W. Badger, aged 66 years, died at his residence at St. Elmo at an early hour Sunday morning. He was one of the most widely known farmers in this section and leaves a wide circle of friends to mourn his death. Interment will be made in Boggy Cemetery Monday afternoon.

Floyd and Lucinda Blundell (ca. 1938 - ca. 1943)

The 1940 U.S. Census shows Floyd and Lucinda Blundell as the renters of this house. Floyd Blundell was 48, had been born in Texas, and was a dishwasher in a café. Lucinda Blundell was 50, had been born in Texas, and had no occupation listed. They had 2 daughters: Willie B., 18; and Mary Lou, 12. The family had lived in rural Caldwell County, Texas in 1935. The 1930 U.S. Census shows Matthew F. [Floyd] and Lucinda Blundell living on a rented farm in Caldwell County, where Floyd was a general farmer.

LOCKHART—Floyd Blundell, 73, died at his home here Tuesday. A native of McMahan, Blundell worked as a salesman in Austin until his retirement six years ago. Services are pending at Field Funeral Home.

Carl G. and Dorothy Barho (ca. 1946 – ca. 1950)

No census records appear to exist for Carl and Dorothy Barho. He died in Austin in 2000; after he and Dorothy lived in this house, he sold it to his sister, Annie Barho, who had married Arnold L. Cain (see below).

Carl G. Barho Sr.

Carl G. Barho Sr., was born in Austin, Texas, on May 13, 1921. He died on Monday, October 16, 2000, after a brief illness.

His wife, Dorothy, whom he married on January I8, 1942, survives him.

They were blessed with two sons. Carl G. Barho Jr., (Butch) and wife, Miki, of Georgetown, Texas, and Eddie Barho and wife, Rae, of Lake Travis; four grandchildren, Greg Barho and wife, Belinda, of Bastrop, Texas, Corby Barho and wife, Tracy, of Pflugerville, Texas, Cindy Henderson and husband, Mark, of Arlington, Texas, and Casey Barho of Georgetown; and four greatgrandchildren, Madison, Kristen, Kolton and Kaleb. Three sisters survive him, Emma (Mrs. E. H. Oertli, Jr.), Annie (Cain) and Lois (Mrs. Claude Hausenfluke); and many nieces and nephews and friends.

Besides his parents, Leo and Charlotte Barho, he is predeceased by two sisters and three brothers.

After serving in the Navy from 1943-1945. Carl returned home to find his life's dream by going to work for Mr. Dewey Bradford in 1950 at the Country Store Art Gallery. Mr. Bradford brought art to Austin and the Southwest many years before it was accepted as a lifetime vocation. Carl's goal in life was to promote art. His knowledge of art was outstanding and he was sought after to authenticate artwork. He retired from the Country Store Gallery in 1983, but continued his support of and interest in art many years after his retirement.

Carl took an early interest in assisting the deaf community in Austin. He was a founder of the Vaughn House, a unique facility for multi-handicapped deaf persons. He served on its board from the time of its initial meeting in 1969.

Carl was an active member of Grace United Methodist Church where he servedinmany capacities over the years.

The family will receive friends on Wednesday from 7:00 till 9:00 p.m. at Harrell Funeral Home. Funeral services will be held at the funeral home on Thursday, at 10:00 a.m. with the Reverend Jeannie Whitehurst officiating and the Reverend John Gilbert assisting. Burial will follow in Austin Memorial Park, 2800 Hancock Drive.

Arnold L. and Annie (Barho) Cain (ca. 1954 -)

Arnold L. Cain's 1982 death certificate shows that his wife, Annie, was born Annie Barho, the sister of Carl Barho, who had owned the house in the late 1940s. Arnold Cain was a railroad engineer for the Southern Pacific Railroad who had been born in Creedmoor, Texas in 1916. He appears in the 1930 U.S. Census as the 12-year old son of William D. and Maggie Cain, who rented a house at 4501 Avenue F in Austin. His father was an odd jobs laborer. No one else in the household had an occupation listed. The 1940 U.S. Census may show this Arnold L. Cain (he is the right age) but married to a woman named Dorothy. This Arnold L. Cain lived at 1707 E. 4th Street in Austin and was a cook in a cafeteria. Their son, Arnold Lee Cain, Jr. was born in 1937 – his mother's name was Dorothy Dotson Cain. Arnold and Dorothy Cain apparently divorced. She died in Austin in 1979.


Arnold Lee Cain, Sr., 66 years old, of 1704 Eva Street, Austin, died Wednesday.
