# HISTORIC LANDMARK COMMISSION JULY 28, 2014 DEMOLITION AND RELOCATION PERMITS HDP-2014-0567 1901 WILLOW STREET

#### **PROPOSAL**

Demolish a ca. 1922 house.

#### ARCHITECTURE

One-story, rectangular-plan, pyramidal hipped-roof frame house with a partial-width inset porch; single and paired modern replacement windows with a 6:6 pane configuration.

#### RESEARCH


The house was built around 1922; Richard H. Ebner was the first owner and occupant. Ebner was a widower when he moved into this house; he lived here with his widowed mother, Agnes, and his son, Gerhard [Monroe] until around 1934. Richard Ebner was a fireman for the Southern Pacific Lines. His son, Monroe Ebner and Monroe's wife, Olivia, are then listed as the owners and occupants in the 1935 city directory. They lived there until around 1936, when the house became a rental unit until the mid-1940s. Among the tenants were a taxi driver and a plasterer. Mrs. Bertie Richey, a widow, owned and occupied the house from the mid-1940s until the early 1950s. She and her carpenter husband had lived on Willow Street in 1920, but had moved to Fort Worth by 1930, where they continued to live until Joseph's death and Bertie's return to Austin. In the early 1950s, the house was purchased by Jose [Joe] and Vicky Rios, who lived here for the rest of their lives. Joe Rios was a laborer at Austin Metal and Iron before he moved into this house; he then worked for the City parks and Recreation Department, and later as a janitor at Camp Craft. He retired around 1970. After his death in 1983, Vicky Rios continued to live in the house until her death in 1992.


#### STAFF COMMENTS

The house is listed in the Comprehensive Cultural Resources Survey (1984) but without a priority for research.

#### STAFF RECOMMENDATION

Encourage rehabilitation and re-use of the house to the greatest extent possible. The house has been modified with the replacement of the original windows, but still maintains its basic form and an integral part of the historical context and integrity of East Austin. While the house may not qualify as an individually-designated historic landmark, if the modern modifications were reversed by installing more appropriate windows, this house would definitely be contributing to a potential historic district in the neighborhood. If rehabilitation and re-use is not feasible, then encourage relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

Richard H. Ebner (ca. 1923 – ca. 1933)

Monroe Ebner (ca. 1928 – ca. 1936)

Richard and Hulda Ebner are listed in the 1920 U.S. Census as the renters of the house at 104 Concho Street in Austin. Richard Ebner was 36, had been born in Texas, and was a fireman for the railroad. Hulda Ebner was 30, had been born in Texas, and had no occupation listed. They had a son, Gerhard [Monroe], 9. The 1930 U.S. Census shows Richard Ebner as a widower, and the owner of this house, which was worth \$1,500. He was a locomotive fireman. With him lived his son, Monroe, 18, who had no occupation listed; and his mother, Agnes, a 68-year old Texas-born widow with no occupation listed. By 1940, according to the census report of that year, Richard Ebner was living alone in an apartment at 2005 E. 1<sup>st</sup> Street. He was a locomotive fireman.

By 1940, Monroe and Olivia Ebner were living in Clay City, Illinois in a rented house. Monroe Ebner was a 28-year old mechanic in an oil field. Olivia Ebner was 29, had been born in Texas, and had no occupation listed.

#### Jacob P. and Delta Heath (ca. 1938 - ca. 1940)

J. Pinkney and Delta Heath appear in the 1940 U.S. Census as the renters of an apartment at 1510 W. 9<sup>th</sup> Street in Austin. J. Pinkney Heath was 52, had been born in Texas, and was a taxi driver. Delta Heath was 51, had been born in Texas, and had no occupation listed. They had 2 children: Lois, 16; and John, 14. Both had been born in Texas and neither had an occupation listed.

#### Oscar and Ethel Overstreet (ca. 1940 – ca. 1943)

Oscar and Ethel Overstreet appear in the 1940 U.S. Census as the renters of the house at 2010 Willow Street in Austin. Oscar Overstreet was 38, had been born in Texas, and was a plasterer. Ethel Overstreet was 39, had been born in Texas, and had no occupation listed. They had a daughter, LaNelle, 10.

#### Bertie Richey (ca. 1946 – ca. 1954)

Bertie and Joseph Richey appear in the 1920 U.S. Census as the tenants of the house at 1411 Willow Street in Austin. Joseph Richey was a 43-year old Kentucky-born house carpenter; Bertie Richey was 40, had been born in Texas, and had no occupation listed. They had 2 children: Evelyn, 9; and William, 6. Both children had been born in Texas. With them lived Joseph's father, Columbus Richey, 75, who had been born in Kentucky and had no occupation listed. By 1930, the family had moved to Fort Worth, where they rented a house. Joseph Richey was a carpenter in general construction. Their oldest daughter, here listed as Adine, now 19, was a clerk in a dry goods store. William had no occupation listed. The 1940 U.S. Census shows Joseph and Bertie Richey renting a house in Fort Worth, where Joseph had a general repair shop. None of their children were listed as living with them.
