#### **BACKGROUND** Resolution No. 20100930-023

Instructs City Manager to investigate:

- 1) Requiring all C&D sites to recycle or salvage
- 2) Creating incentives for recycling and salvaging
- 3) Creating an economic-hardship fee waiver for the demolition and relocation permit fee
- Applying a portion of the demolition and relocation permit fee toward preservation review





#### **BACKGROUND** ARR Master Plan

**Construction Materials Management:** 

- Adopt policies to increase reuse, recycling and composting of products used in additions, renovations, and new construction
- Require large scale project building permits holders to provide diversion plans
- 3) Transition to higher rates of diversion requirements
- 4) Register C&D debris facilities and haulers

#### CONSTRUCTION MATERIAL RECYCLING ORDINANCE

By resolution, the Austin City Council directed city staff to investigate requiring construction and demolition sites to recycle or salvage materials. The goal is to develop an ordinance that also supports the City's Zero Waste goal and the Austin Resource Recovery Master Plan.

Austin Resource Recovery, the Planning and Development Review Department, Austin Energy Green Building, Austin Code Department, and the Office of Sustainability are conducting a collaborative stakeholder process to draft a construction material recycling ordinance for City Council consideration.

#### Join the Process

City staff is gathering stakeholder input for a draft ordinance through several public meetings.








# **BACKGROUND** Austin Energy Green Building

- Voluntary within Austin Energy Service area
- Mandatory
  - Downtown
  - SMART Housing
  - Mueller
  - UNO
  - PUD









## Austin Energy Green Building 2013 Basic Requirement

**Construction Waste Management:** 

- Recycle or salvage >50% by weight C&D material, excluding excavated soil, stone, and land clearing debris
- Diverted material must include at least four material streams (i.e., concrete, metal, wood, cardboard, paper, plastic, drywall)







## **Austin Energy Green Building** Construction Waste Management

2013	Number	Square Feet	Generated (tons)	Diverted (tons)	% Diversion	Generated (lbs/sf)	Disposed (lbs/sf)
Commercial	15	2,035,035	17,488	14,192	81%	17.2	3.2
Multifamily	12	1,758,814	11,891	9,293	78%	13.5	3.0
TOTAL	27	3,793,849	29,379	23,485	80%	15.5	3.1





#### Ordinance Potential Impact Landfills & Haulers, 2013

- Landfills (4 Type I, 1 Type IV) reported
  - 400,000 tons of C&D
  - 20% of what they handled
- Licensed haulers & ARR
  - Disposed 1.2 million tons
  - 20% of 1.2 million tons = ~240,000 tons of C&D





# Ordinance Potential Impact Processing



- 5 Commingled C&D
- 8 Concrete, rubble
- 12 metal scrap
- 10 wood scrap
- 5 Reclaimed asphalt pavement
- 3 Reclaimed asphalt shingles
- 3 Carpet & carpet padding











#### **Program & Ordinance Types** Green Building

- Examples

- End-use restrictions





#### Program & Ordinance Types Deposit & Refund

- Examples
  - Plano TX
  - San Diego CA
  - San Jose CA
- Refund
  - Proportional to recycling rate
  - Performance based





#### Program & Ordinance Types Post-Project Fee

- Performance-based fee
  - Chicago IL
  - Madison WI
- Flat fee (fine) for noncompliance
  - Portland OR
  - Lee County FL





#### Program & Ordinance Types Qualified Processors

- Examples
  - San Francisco CA
  - Chatham County NC
  - Orange County NC
  - LEED credit
- Project: submit plan but not report
- Processor
  - Report
  - Auditing





#### **ORDINANCE PARAMETERS** Affected Projects

- Size of project
- Type of project
  - Demolition
  - New construction
  - Renovations
- Type of use
  - Residential
  - Multi-family
  - Commercial/Mixed Use





#### **ORDINANCE PARAMETERS** Project Requirements

- Diversion minimum percentage
- Materials number or specified
- Plan, Track, Report
- Eligible on-site practices
  - Salvage
  - Onsite reuse or recycling
- Provide credit for:
  - Reducing generation
  - Use of salvaged or recycled-content building materials or products





### **ORDINANCE PARAMETERS** Hauler & Processor Requirements

#### Hauler

- License
- Report: by project, annually

#### Processor

- Source-separated material processors
- Mixed-material processors
- Qualifying end-uses
