Authorize award and execution of a 36-month requirements supply contract with HD SUPPLY WATERWORKS, LTD for the supply of pipe adapters for the Austin Watery Utility in an amount not to exceed \$173,958, with three 12-month extension options in an amount not to exceed \$57,986 per extension option, for a total contract amount not to exceed \$347,916.

Amount and Source of Funding

Funding in the amount of \$4,832 is available in the Fiscal Year 2013 – 2014 Operating Budget of the Austin Water Utility. Funding for the remaining 35-months of the original contract period and extension options is contingent upon available funding in future budgets.

**PRICE ANALYSIS**

- a. Sole bidder.
- b. One hundred twenty-five notices were sent, including 7 MBE and 5 WBE firms. One bid was received. No MBE or WBE firms responded.
- c. The pricing offered represents a 3% decrease from the previous contract awarded March 2011.
- d. This is the second time we bid this project. The first time we extended the bid opening twice and contacted bidders however, we received no responses. When this solicitation was issued bidders that bid previously on the last contract, with the exception of one who could not be reached, were contacted and HD Supply was the only respondent.
- e. HD Supply Waterworks LTD is not the current contractor.
