## Subject

Authorize award and execution of a 36-month requirements service agreement with AUSTIN SOFTBALL UMPIRES ASSOCIATION to provide adult softball umpire services in an amount not to exceed \$910,572 with two 12-month extension options in an amount not to exceed \$303,524 per extension option, for a total contract amount not to exceed \$1,517,620.

## Amount and Source of Funding

Funding in the amount of \$50,587 is available in the Fiscal Year 2013-2014 Operating Budget of the Parks and Recreation Department. Funding for the remaining 33 months of the original contract period and extension options is contingent upon available funding in future budgets.

This service agreement is for adult softball umpire operations and management of all City-owned and operated softball programs. Services provided by this contract will include the scheduling of umpires for each game, training and certification of all umpires, and related administrative services.

All umpires of this association have been through a local training school consisting of 12 hours of classroom training and 12 hours of actual on-field training under game conditions. Umpires will be officiating league and tournament games throughout the summer, spring, fall, and winter. Approximately 8,855 games are played each year at various City softball complexes.
