Approve the garage apartment as proposed.

COMMENTS: Take the addition to a single gable in place of a double gable. Do not change the windows on the front façade from a single window configuration to a side by side double configuration.

Proposal: Demolish a ca. 1906 house.

Staff Recommendation: Encourage rehabilitation and re-use if feasible, but otherwise release the permit and strongly encourage the applicant to

consider the scale and architectural context of the surrounding historic houses in the neighborhood in designing a new house for this site.

MOTION: Release the demolition permit in accordance with the staff recommendation; as per passage of the consent agenda on a motion by Commissioner Myers. Commissioner Roberts second the motion on a 5-0 vote.

3. HDP-2014-0491

3402 Clawson Road

Proposal: Demolish a ca. 1950 house.

Applicant: Max Hambly

City Staff: Steve Sadowsky, Historic Preservation Office, 974-6454

Staff Recommendation: Strongly encourage the applicant to reconsider demolition and rehabilitate and reuse the existing house and setting if feasible; but otherwise, release the permit upon completion of a City of Austin Documentation Package.

David Jones and Marsha Topham spoke in support of the demolition. Sharron Howell originally signed to speak in opposition but spoke in support after finding out more information. The public hearing was closed on a motion by Commissioner Galindo. Commissioner Roberts second the motion on a 5-0 vote.

MOTION: Support the staff recommendation to release the demolition permit on a motion by Commissioner Roberts. Commissioner Wolfenden-Guidry second the motion on a 5-0 vote.

Staff Recommendation: Encourage retention and re-purposing to the greatest extent possible, but if not feasible, then encourage relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package.

The public hearing was closed on a motion by Commissioner Wolfenden-Guidry. Commissioner Galindo second the motion on a 5-0 vote.

MOTION: Postpone the public hearing to August 25, 2014 to allow staff to do additional research on a motion by Commissioner Myers. Commissioner Roberts second the motion on a 5-0 vote.

Proposal: Demolish a ca. 1915 house.

Staff Recommendation: Encourage rehabilitation and re-use of the structure if it is structurally sound. If not, then encourage relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package.

MOTION: Release the demolition permit in accordance with the staff recommendation; as per passage of the consent agenda on a motion by Commissioner Myers. Commissioner Roberts second the motion on a 5-0 vote.
