PROPOSAL

Demolish a ca. 1904 house.

ARCHITECTURE

One-story, wing-and-gable plan frame house with a partial-width, shed-roofed, independent porch on plain, square wood posts; single and paired 1:1 fenestration; standing seam metal roof.

RESEARCH


The house was built around 1904. The first known occupant was Page McDannell, who had a wholesale liquor business on E. 6th Street. He lived here until 1906, when he passed away. The house was occupied by Mrs. E.J. Harvill for a few years, and then by a candy maker for McNamara Brothers, a local confectioner; then from around 1913 to around 1920, the house was occupied by Domenico Milice (variously spelled as Milicia, Melicia). Domenico was a native Italian, who ran saloons in and around the current Warehouse District (but at that time, in the city's red light district) before opening a grocery business on the east side, where he later moved. Michele (Mike) and Lydia Falcone then occupied the house from around 1920 until their deaths in the early 1960s. Mike Falcone was also a native of Italy, and first work in a granite mine, like many of his compatriots. He then worked for the City utilities in various capacities, and finally became a tile setter, first with Trafton Tile and Marble, and later with Capitol Tile Service, and his son's business, Modern Tile Service. After Mike and Lydia Falcone's deaths in the 1960s, the house became a rental property.


STAFF COMMENTS

The house is not within the Rainey Street National Register Historic District, but is listed as a priority 2 for research in the Comprehensive Cultural Resources Survey (1984).

STAFF RECOMMENDATION

Encourage relocation over demolition, but release the permit upon completion of a City of Austin Documentation Package, consisting of photographs of all elevations, a dimensioned sketch plan, and a narrative history, for archiving at the Austin History Center.

Page McDannell, aged 77 years, and one of Austin's oldest and best known business men, died yesterday afternoon shortly after 6 o'clock at his residence, 269 East Sixth street.

Mr. McDannell had been in bad health for two years or more, though the immediate cause of his death was pneumonia, which he contracted some two weeks ago.

Besides his wife, he is survived by a son, Will McDannell of this city, and a brother in San Angelo. Announcement of the funeral will be made later.

Domenico and Cruz Milice (ca. 1913 – ca. 1920)

The 1910 U.S. Census shows Domenico and Cruz Milice living at 1412 Willow Street; Domenico was the proprietor of a restaurant. Domenico and Cruz Milice appear in the 1920 U.S. Census at an unlisted address, but they are shown to own the house. Domenico Milice was 42, had been born in Italy, and is listed as a merchant. Cruz Milice was 28, had been born in Texas to Mexican-born parents, and had no occupation listed. They had 5 children, ranging in age from 2 to 13. All of the children had been born in Texas.

The 1930 U.S. Census shows Domenico and Mary Milice living at 2733 E. 5th Street, a house they owned, and which was worth \$1,000. Domenico Milice is listed as the proprietor of a grocery store. Mary Milice (Cruz) had no occupation listed, but is now shown as a native of Mexico. Their 5 children lived with them; son Angelo, 21, was a truck driver for the State Highway Department, and son Joe, 17, was a helper in a tile business.

Mike and Lydia Falcone appear in the 1920 U.S. Census as the renters of this house. Mike Falcone was 46, had been born in Italy, and was a foreman in a granite mining operation. Lydia Falcone was 36, had been born in Texas, and had no occupation listed. They had 3 children: Charles, 21; Debo, 9; and Victoria, 16. All the children had been born in Texas. The 1910 U.S. Census shows Michael and Liddie Falconi living at 1705 Willow Street; they had 3 children: Amelia, 12, Charles, 10, and Victoria, 7. Michael was a saloon keeper.

The 1930 U.S. Census shows Mike and Lydia Falcone as the owners of this house, which has the old address of 93 Red River Street. The house was worth \$1,000. Mike Falcone is listed as a 53-year old Italian-born general laborer. Their son Debbs, 19, was a tile-setter's helper. No other family member had an occupation listed. The 1940 U.S. Census shows Mike and Lydia Falcone as the owners of this house, which has the current address of 91½ Red River Street. The house was worth \$1,500. Mike was a tile setter's helper; Lydia had no occupation listed. With them lived their son, Jack, 15, who had no occupation listed.
