ANALYSIS / ADDITIONAL INFORMATION: Austin Energy is seeking approval of this budget amendment to provide additional appropriations and related funding for the Voluntary Utility Assistance Fund. The Voluntary Utility Assistance Fund provides financial assistance to qualifying low-income customers for help with their utility costs. The Voluntary Utility Assistance Fund combines funding donated by City of Austin customers through an election on their utility bill with funding from Austin Energy. Austin Energy provides \$300,000 to this program each fiscal year. This amendment will provide an additional \$600,000 in funding from the Austin Energy operating budget to provide funding for the increased demand from qualifying customers for this programfor this program.

The above five-year impact analysis illustrates the total revenue and expense projections for the Austin Energy Operating Fund.
